

# PROPOSED AMENDMENT TO CLUB CONSTITUTION

Submitted by Archie A. Black CH-001

In accordance with Article Six, Section 1: ALTERATIONS OR AMENDMENTS, I propose the following amendment be added to Article Four, Section B) of the club's Constitution:

"In order for a potential candidate to be declared an official nominee in any club election for office, the candidate must receive the equivalent of a nomination and a second in order to be listed on the official ballot as a valid candidate. To accomplish this requirement, a candidate must receive a minimum of two nominations.

Article Six; Section 1 "Alterations or Amendments" states the following:

"This Constitution may be altered or amended. Alterations or amendments shall be presented in writing to the President who shall cause written notification to be provided to all members. Ballots containing any proposed alteration or amendment of this Constitution shall be mailed to each member at least 30 days prior to an annual meeting and shall specify the procedure for casting ballots in advance of the annual meeting. A two-thirds majority of those voting shall be required to amend."

# CC&GTCC CLAIMS DIRECTOR REPORT

The club's new "Claims Director", Jim Reilly, has thrust himself wholeheartedly into his new position. In addition to Jim's duties as Claims Director, the club officers have consulted Jim for his opinion on several legal issues that have arisen since his appointment. What a great addition Jim Reilly Esq., has made to our all-volunteer staff.

The following is a report on the final resolution of Jim's first complaint he has handled between the two parties in dispute.

CC&GTCC Claim No. CC199902: This claim arose out of a trade in which the material sent by one member was lost in the mail as the result of inadequate packaging by the sender (unreinforced envelope). An exchange of email between the members following the loss of material escalated to the point where one member used offensive language in his email to the other. One of the two members refused to cooperate fully with the Claims Director in the investigation of the claim.

The trade having eventually been made good to the satisfaction of both parties, the Board finds no need to take action in that regard. Nevertheless, the Board finds this an appropriate opportunity to remind members to adequately package trade materials sent by mail to insure their safe arrival. Use of UN-reinforced envelopes is inadvisable, all materials should be sent in reinforced envelopes, bubble pack mailers, USPS priority mail packages or boxes, or comparable packaging, as appropriate.

The Board also finds that the use of offensive language in correspondence between members of the club is inappropriate. I attempting to resolve disputes between and among themselves, members are encouraged to be calm, courteous and civil to each other.

The Board also finds that the failure of one member to cooperate with the Claims Director in conducting his inquiry into this matter was inconsistent with Paragraph 13 of the CC&GTCC Code Of Ethics, by which members agree "to cooperate fully with officers of the Club in investigating and resolving problems which may arise, and complaints which may be made, and to provide such information to such officers as may reasonably be requested."

The conduct involved in this incident is not sufficiently serious to warrant public identification of the individual members involved.

# EX-CLUB MEMBER TEMPORARILY SUSPENDED FROM RE-ADMISSION TO CLUB

Casino Chips & Gaming Tokens Collectors Club Claim #199903

This claim has been submitted by member Howard Herz against former club member Larry Eastman (CC&GTCC member #1530, membership expired and not renewed)

The claim arises out of the disappearance from the home of Howard Herz, Minden, Nevada of two rare and valuable gaming checks: \$1000 Ceasar's Palace gold baccarat chip with enameled lettering, serial number 523, estimated value \$2500; and \$25 Caesar's Palace blue with .999 silver inlay, estimated value \$1600 (see p. 13 CC&TN Vol 12, #1, Winter 1999).

Following an investigation by the Douglas County, Nevada Sheriff's Department, Larry Eastman was charged a single count of theft, a class B felony in the State of Nevada, for taking the two checks. The criminal complaint is currently pending in the Justice Court of East Fork Township, County of Douglas, State of Nevada.

On the basis of the criminal charge, the Board finds that Mr. Eastman will be prohibited from re-applying for membership in the club and will be prohibited from participating in any club activities pending the final outcome of his case.

The Board reserves further action in this claim until the conclusion of the criminal proceedings. At that time, the Board will determine what further action, if any, should be taken and what details of the incident should be published.



# Gaming Library Grows with New Guide Books

Library listings on-line at www.ccgtcc.com by Robert Pardue (CH-003) CC&GTCC Librarian

The CC&GTCC Gaming Library continues to grow with a total of 14 new titles added this quarter. The continued generosity of club members — and especially authors of recent guide books on chips and tokens—resulted in key additions which I'm sure club members will enjoy for years to come.

Interest and activity in the club's Libraryby-Mail service has picked up in the last quarter, with the publication of all books and materials in the last issue of Casino Chip & Token News. A list of books is also available on the club's website at www.ccgtcc.com. With an e-mail link to the club Librarian (yours truly!), it's easier than ever to inquire if a book is in stock and to check-out books from the library. And if you prefer, mailing your request will get a promt reply, too.

# New chip guides

The most popular category of books is chip and token guides. Newer members, especially, are utilizing the library's resources by frequently requesting current editions of The Chip Rack and The Gaming Table. The only problem -- these books always had a waiting list. The solution--KMW Publishing (that's Michael Knapp, Allan Myers and Ernie Wheelden) donated extra copies of these two key books. Now we have a total of 4 Gaming Table (1998) books and 2 Chip Rack (1998) books, plus previous editions for the library's historical records. Thanks, guys!

Puerto Rico chip collecting has been an undocumented specialty area for many years. To shed some light on this area, Archie Black has donated a copy of his new 1999 Black's Catalog of Puerto Rico Casino Chips. Similar in format to the popular Black's Atlantic City guide, this well-researched presentation on Puerto Rico chips includes both a descriptive listing of known chips, by casino, plus color photos. A value guide is included. Very nice first edition for this subject area.

Shifting to Colorado collectibles, author Gary Johnson has donated a copy of his new 3-ring binder guide titled Colorado Limited Stakes Gaming Casino Chip and Token Guide: The Early Years. A very comprehensive listing of both chips and tokens, Gary's research has uncovered rare samples, patterns, errors and varieties, as well as all the regular issue and limited edition chips and tokens associated with casinos in the Colorado mining towns during the first seven years of limited-stakes gaming--Oct. 1 1991 to Oct. 1 1998. In these short 7 years, the small issue quantities, coupled with increasing demand and popularity for rare items among the enthusiastic Colorado collectors, has created a handful of high-value items. The itemized description of each chip and token includes a value estimate. Over 40 Colorado items are assigned values over \$1000, though some of these are unique pieces. The typed description for each chip or token is easy to understand, but is not accompanied by any photos, except for the tantalizing color photo of some rarer items on the cover. The book is an important edition to recording Colorado items, and is especially useful when read in conjunction with a companion guide with photos.

Nevada Silver Premium Gaming Tokens is the title of an interesting and expanded edition by Marvin Weaver. This updated issue is the 4th Edition-1999 Price Guide on this topic, and author Marv Weaver thoughtfully donated 2 copies to the club library. The guide lists "silver strike" tokens by casino, using a color-coded method which distinguishes "current" items from "retired" and "obsolete" tokens. Updated 1999 price estimates are included for each token. An informative appendix includes side-by-side color photo comparisons showing the difference between certain variations of similar-looking gaming tokens. A listing of mint marks and other helpful identification tools makes

this new 1999 edition a very useful reference for Silver Premium Gaming Token collectors. Weaver's guide has been updated with many new finds, and has been revised to reflect the status of these specialty collectibles. Unfortunately, Silver Strike machines can be removed with little or no notice, and after removal, the SPT's can be very difficult to obtain.

#### CC&GTCC back issues sought

The club library now receives its own copy of our quarterly magazine, beginning in 1999, so future members will be able to review back issues in the years to come. However, we are interested in building a complete set of issues from the first 10 years of publication. Several members have promised to dig through closets and donate duplicate issues found. However, if you have an extra set (or partial set) of issues you would like to contribute, please contact me. Thanks in advance for the help.




Left: Black's Puerto Rico Guide - 1999 Edition: Excellent first compilation of chips from the casinos of Puerto Rico.




Center: Johnson's Colorado guide to the chips and tokens from mining town casinos issued between late 1991-1998.

# ON THE SEA OF LOST AND FORGOTTEN CHIPS

For the past nine years I have been diligently researching and writing the history of the Gambling Ships that operated off the Southern California coast from 1927 to 1939 and again in 1946. Over a period of 12 years there were 14 different gambling ships. A few however, were the same vessel only the name changed several times. Such was the case recently while I was on a casino token expedition to Atlantic City. The Trump Marina has already issued new \$1 and \$2 tokens, with other changes in the work to eventually replace all of the prior Trump Castle tokens.

Likewise, the Tropicana Hotel has recently put out new \$1, \$5, \$25, \$50, & \$100 tokens replacing the older "Trop World" tokens while still retaining the \$2 & \$10 Trop World tokens until later.

The Sands has completely replaced all "Hollywood Casino" \$2 &\$10 tokens with a new attractive Sands Hotel logo.

It was with this in mind that I started my 150 mile journey (1 way) to Atlantic City. Why not, Trump Marina has been in transition from Trump Castle for a year now, Tropicana has been a year and a half, and Sands has finally divested itself of the "Hollywood" theme, and reverted back to it's old name. There must be new tokens in place by now - right?.....wrong!

The trip was a complete bust after several losing sessions at the black jack table, so with heavy heart, I headed back for Maryland and home.

Between Maryland and New Jersey is a small state named Delaware which boasts 3 racetracks, which also include slot machines. Not having been there in almost a year, I decided to try my luck. At Delaware Park I noticed a new addition on the lower level called "High Rollers".

Upon checking it out, I noticed a new design \$2, \$5 and a completely new \$10 denomination. The \$5 was the previous high. The slot attendant informed me that a \$25 token will be in play any day now.







On a hunch, I sped 50 miles south to Dover Downs and was also presently surprised. While the \$1, \$2 and \$5 tokens were unchanged, there are completely new \$10 and \$20 tokens in play.



Which proves my point. Don't go elsewhere looking for new finds before checking your own back yard. You may be surprised by what you overlooked.

# Atlantic City Report

This will be one of my shortest A.C. reports since I began writing this column... only because not too much has happened in Atlantic City since the previous issue of the club magazine was published. In fact, between late November, 1998 and mid-February, 1999, no new "live" chips were issued...... NONE!

We left off in the last issue of "Casino Chip & Gaming Token News" with the report of a Tropicana release of a Thanksgiving Day chip in November .... and that's where we pick it up this quarter. Since then, the only chip issued was again at Tropicana with their release of 2000 "Year Of The Rabbit" (Chinese New Year) chips on February 16, 1999.






The previously announced chip in the Gaming Legends series that was to be issued at Claridge never happened. Reason given was that Claridge had too many unsold Bell(e) Starr chips still in their inventory and any new chips would not be released until the over-supply of the Starr chip was depleted. Hah, fat chance! Don't think so! 5000 chips of Bell Starr were offered for distribution in a market that only supports up to half that number.

Meanwhile, over at Resorts, they issued the 21st chip in their 20 chip series to celebrate their 20th Anniversary. Sounds confusing, doesn't it? Well it's true. Resorts had issued a nice attractive chipbook album at the end of their promotion with holes for 20 of their No Cash Value "Chip Of The Week" series in which players had to put five points each week on their Resorts Player Card in order to qualify for the NCV chip giveaway. One point equals \$50 through the slot machine machine, or two hours of table play at an average minimum bet of \$10 per hand. You do the math to determine how much action one had to give in order to get! After everyone thought they had completed the 20 chip series.... guess what? The "coming soon" 1998 chip, that was advertised in their colorful tri-fold brochure "TO BE RELEASED BEFORE THE END OF THE YEAR" which illustrated the entire series, was released in January, 1999.



Finally, other than a new \$100 chip at Harrah's Marina, no other chips were issued in Atlantic City this past quarter. Amazing! I'm told that a lot of the cut-backs of new chip issues has to do with new accounting regulations enacted by the State which requires frequent inventory counts of limited edition/commemorative chips on the tables that in-turn represents a significant labor cost the casinos don't want to endure.



MORE ON THE CLUBS ALONG HIGHWAY 90 NEAR VINTON, LOUISIANA

An earlier issue mentioned some illegal clubs along Highway 90, east of the Texas border into Louisiana. Thanks to Glyn Farber of Lake Charles, Louisiana the following information from the December 27, 1987 Lake Charles American Express newspaper was received.

Above is a map showing some of the clubs that were along this strip of Highway 90 from the Texas border, through Vinton to Lake Charles, Louisiana. There were many more that came and disappeared. Shown here are Demary's Border Club, German Beer Garde, Showboat, Buster's, Flamingo, Stompin' Henrys, Sabine Club, Lou Anns, Crystal Palace, The Groves. These were all west of Vinton, Louisiana. Heading east towards Lake Charles, Louisiana were the Casa Blanco, Little Forest Club, The Oaks, Loma Linda, Speedy's Broken Mirror, Tip Top, Silver Star, Camel's Oasis, Joe Rachel's, Manhattan and Bat Gormly's. Highway 90 gave in to Interstate 10 around 1953 and most of these places disappeared.

As mentioned, there were many more that appeared and disappeared. Chips are known and are in collections from the Border Club, Buster's and the Grove. Chuckster's, 4632 S Maryland Pkwy LV \$1 (1998) RWM, Cardivan. Original (1994) CT, Desert Coin is obsolete. Laughing Jackalope Bar & Grill, 3969 LV Blvd S, LV \$1 (1998) RWM, Cardivan. Pretty much same design as previous

token, but new die, new mint & new route company. (1997) G, Anchor Coin is obsolete.





Hang'n Loose, 208 E Sahara LV \$1 (1998) OC, South West Gaming. This was the closed Go's West. Next Door Lounge, 3750 S Valley View LV \$1 (1998) OC, South West Gaming. This was Marty's Bar & Grill. All Marty's tokens are obsolete.





Pogo's Tavern, 2103 N Decatur LV. Original \$1 (1991) CT-large, United Coin. Some time ago another token was issued (again no gaming approval listed). We will call CT-large Type I and newly found token as (1991) Type II, CT-mini, United Coin, as there is no real way of determining when this second token was issued. Club Hotel by Doubletree, 7250 Pollack Dr LV. Small bar in a new hotel, southwest of McCarran Airport. \$1 (1999) OC, South West Gaming. Speedway Bar & Grill, 4224 N Pecos LV \$1 (1999) GDC, United Coin.





Another reverse die date (like Cariba Charlie's) has been found at Gloria's II, 1966 N Rainbow LV. Original token is (1992) with old reverse die date of second token, found recently, is still same obverse, but reverse die is dated 1992. these will be listed as type I (1992)/1989 and type II as 1992.

Durango Park Chevron, T&C Enterprises, 8635 W Spring Mtn Rd LV \$1 (1999) OC, South West Gaming. This is a gas station/McDonalds Restaurant combination!!! The token is in the convenience store of the gas station.



Las Vegas Cue club, 953 E Sahara LV has also turned up a second variety token. Type I-CT mint mark is extra large and has small dots on reverse rim. Newer Type II-CT is large and has large dots on reverse rim. The Corner Bar, Mesquite \$1 (1999) CT, E-T-T-, Inc. This token is not being used in machines, but can be purchased at bar for \$1.25! Token is same design as original (1996) United Coin.

Bleachers Sports Bar, 3720 E Sunset LV is now Little Dogs, open 12-98. All paper pay outs-no tokens. All Bleachers tokens are obsolete. Blueberry Hill Restaurant & Lounge, 2855 N Green Valley, Hend open 11-98. \$1 (1998) RWM, Cardivan. (same design as token at 4435 LV Blvd N, NLV). This was USA Cafe and all USA Cafe tokens are obsolete. Mattie's Elko has been found with two types also. Type I- \$1 (1997) CT-mini, United Coin and Type II-\$1 (1997) CT-large, United Coin.

After only one month in play Lois' Sunrise Liquor has removed dollar machines and new token is obsolete. Gone to coinless or paper payouts-all tokens obsolete: Office Bar #7, 2660 S Maryland Pkwy, C.D.'s Lounge, 3025 E Desert Inn, Favorites Cocktails, 4110 S Maryland Pkwy, Max Bett's Fun Hog Ranch, 495 E Twain, Rascal's Lounge, 860 E Twain, Skinny Dugan's, 4127 W Charleston, Magoo's Bar & Grill, 7360 W Cheyenne, Meatheads Tenaya LLC, 3250 N Cheyenne, B T's Pub, 1651 Palm, Lakes Lounge, 2920 Lakes East Dr, Ozzie's, 5020 Spring Mtn, Boomer's, 3200 Sirius. All are LV. Pat Hand Lounge, 6250 Mountain Vista, Hend.

# PHIL'S FORAYS THE LONELIEST ROAD Phil Jensen #118

A few years ago, Life Magazine I think it was, did a story about "The Loneliest Road In America". Basically it was about U.S. 50 as it stretched from Gallon to Ely - some two hundred and fifty miles of not much of anything. I was quite amused by it as I had traveled that very road many times in my search for old and current casino chips.

Since Fallon was only sixty miles from Reno, I went there often. There were some neat joints there although clubs such as the Esquire, Keystone, Owl, Pastime, Jet, Eddie's, Star and Lucky Spot had already closed. The Sagebrush, Horseshoe, Frankies, Palace, Nevada Bank and Roadside were still in operation though, but some had ceased live gaming. Nevertheless, there were lots of chips to be had with not too much effort.


My favorite place was the Roadside Inn, also known as Mom's Place. "Mom" was a lady by the name of Emily Mitchell who not only owned the place but was also the twenty-one dealer. She was quite elderly-close to ninety by some accounts but very sharp. She had a crap table next to the 21 game and kept a close watch on it. Many times I would hear her correct the dice dealer as she dealt the cards.

The dice table itself was quite interesting. It was oval in shape with a layout that Mom had designed herself. I remember it had no place to bet the don't pass line. Mom didn't want the players betting with the house! She told me the table was once used in the old Lawton Springs casino outside Reno.

Mom used a 10¢ and one dollar chip with the Roadside name. Some of the dimes only has "10" on them and Mom told me that way she could use them for ten dollars! She also used some green five dollar chips that only had a clover on them. They had been used years earlier at the Old Clover Club downtown. Since most of her clientele were low-rolling service men from the nearby Navy base the five dollar chips didn't see much play.

Among the various chips that Mom gave me were some Star Club roulettes. She and her husband owned the place from 1955 until 1962. I was sorry I had missed all those old places.

Mom died around 1977 and left the Roadside to Alan Childers a local contractor and long-time friend who had previously operated games around Fallon. He radically changed the place removing the walls and partitions enlarging it greatly. He also had a new rack of chips made on the horseshoe mold. Most of the stuff from Mom's was auctioned off including the oval crap table. The new place bore little resemblance to the old with roulette and even Keno being added. Anyway, the place only operated until 1980 when it was closed and demolished.



The Nugget, downtown, was owned by Otto Lauf. He was a great guy who always had time to talk. He would even take me into his office and scrounge around for old chips. I got quite a few old Nugget chips from him one time, and some were twenty-fives and hundreds on the old TK Specialty mold.

Next to the Nugget was the Palace Club and I remember a couple of twenty-one tables and some slots but by 1967 the place had closed and was taken over by the Nugget. You can still see where the entrance was by a large "P" formed by real silver dollars embedded in the sidewalk exists. The silver dollars were removed years ago but I can still remember checking them to see if any were loose.

Next to the Palace was a place called Frankies. It had live gaming in the fifties and sixties but by 1970 the place operated as a bar only. One could usually find a few of the local residents passed out on the floor on the other side of the room presumably where the games used to be. It was absorbed into the Nugget around 1977 and was used partly to build new restrooms on the north end of the Nugget.

Another place I used to spend a lot of time was the Sagebrush Club. Now defunct, it was an old place having been around since the legalizing of gaming. The owner was a Chinese man by the name of Tom Wong who had operated the United Club in Reno in the early 60's. He was usually in the place playing Pan on a second floor ledge that overlooked the casino.

Unlike the Roadside there was a crap table in there that was practically square. I don't know if it was homemade but I've never seen one like it since. Like the Palace, there's still a big iron "S" in the sidewall that marks the entrance.

A couple blocks off Maine Street was an antique shop run by a lady whose family apparently ran the old Keystone Club. She had quite a few chips from there that she sold for a dollar a piece and every time I went to Fallon I'd buy a few. There were three different ones - a red five, a black five, and a ten dollar one that looked like it had been stamped on a roulette chip. Anyway, after a while she ran out and I figured I'd cornered the market.

There was a guy I got to know pretty well by the name of Willie and at one time he owned the Esquire Club at the head of Maine Street. He told me he had a sack full of old Esquire Club chips that he and his buddies took on hunting trips to play poker with. Somehow, over the years, they had become lost and he was never able to locate them much to my disappointment. What he did have though, was a large cardboard box that was about a third full of old Palace Club chips. There were quite a few different ones including some \$5 and \$25 aerodies. Every time I'd go visit him I'd buy a few - I guess I should have bought the whole box! Anyway, the Esquire closed in 1957 and was torn down as it had been damaged by the Dixie Valley earthquake that occurred a couple of years earlier.

In the mid 70's the Horseshoe Club was still open although the live gaming had ceased. One day I wandered in and asked the owner, a guy named Charlie, if he had any of old chips laying around. To my surprise he opened a door under the bar and pulled out several boxes of them. There were twenty-five and fifty cent chips with a picture of a horsehead and horseshoe along with the club name on them. There was only a couple of the dollar denominations but they all matched and were the small crown mold. There were a few five dollar aerodies but they only had a horseshoe on one side and \$5 on the other. Anyway, I bought them all for what was probably a pittance as my chip budget was limited in those days. I wondered what had happened to the dollar denominations and several years later I found out when I ran into an old dealer at the Tonopah Belle in Tonopah. I don't know how many he had but he sold me a box of 100 for twenty dollars. I figured he must have worked there and "saved" them when he left.

Heading east out of Fallon marked the beginning of the Loneliest Road. It was a one hundred twelve mile trek to Austin with not much in between. Just over the mountains was Dixie Valley where the Navy held bombing practice and there was a place called Frenchman on the west side of it. The only building I remember was a small bar-restaurant operation and I would always stop there even though there was no gambling.




Anyway, as one crossed over Dixie Valley, there were signs warning of the low-flying Navy bombers and not to stop. I had never encountered any so I didn't think much about it until one day I decided to explore the ghost town of Fairview which was on the east side of the valley and a short distance off the hiway. As I drove up the mountain I ignored signs to keep out. I parked the truck and began to look around. Just as I located an old safe that was half buried in the dirt one of the Navy's finest came screaming through. He was at eye-level and maybe fifty feet away. Needless to say, it scared the bejeez out of me. I made a mad dash for the truck and bounced down the mountain to the hiway. I would never stop there again!

Austin was always a welcome sight after the long drive from Fallon. The main place there was the Austin Hotel which was a two story building with a neat old bar and attached restaurant. In the bar were a couple of 1935 vintage slot machines, which I enjoyed playing, and a twenty-one table that was usually covered with an oil-cloth. One day I asked the bartender what the chips looked like thinking I was going to get some that said Austin Hotel. He reached under the bar and pulled out a couple of boxes of chips from the old Palace Club in Fallon. I thought it was kind of risky using them since my friend in Fallon had so many. The bartender explained that the game was hardly ever open and there wasn't much of a chance of anybody

slipping in a ringer.

One of the Hotel's residents was a guy by the name of "Swede" Anderson. I could usually find him at the bar having a cool one. He was an interesting guy to talk to and would tell me stories about the Frontier Tavern - a place he used to operate on the other side of the Austin Summit. Naturally I asked him if he had any of the chips from there and he said he did. He went up to his room and returned with a green \$1 Portland Card Co. chip marked with the initials FT. He also gave me creme colored BC Wills with FT only on both sides which he said was used for five dollars. As it turned out they were among the few chips from Austin that were actually made for the place where they were used. Seems everybody else used somebody else's chips! Swede also gave me several trade tokens from the International Hotel down the street - I think they were good for a drink. He seemed to value them a lot more than the chips.

One day I noticed a sign had been added to the restaurant part of the hotel advertising the "Austin Nugget". I thought it looked pretty strange but was told there were plans for a quite a few slot machines to be added. Unfortunately, the hotel burned down shortly thereafter and the Nugget was short-lived.



Next door to the hotel was a place called Clara's Golden which was owned and operated by Clara Williams. She usually opened around 8 p.m. so it was tough to see her especially if I had to drive back to Reno that night. She would always park her 1961 Chevy right in front and the first thing she would do would be to take a cardboard box and go over to the hotel and get it filled with ice which she used to make drinks. She would just set it on the back bar and I guess when the ice melted she would close. Also,

hanging on the mirror was a sign that read: "We reserve the right to refuse service to anyone". I always thought it was funny.

Anyway, Clara was the sole employee in the place and in addition to tending bar she would also deal 21. I remember I and several people were playing 21 one time and everyone wanted a drink. Clara spread the cards and went and got them while we all waited patiently.

The 21 table itself was pretty crude. The legs were basically a sawhorse type of construction but it added some personality to the joint. The dollar chips were actually old wheel chips from the Tahoe Country Club - the ones with the Indian on them. There seemed to be a lot of them around so Clara carved a groove in the ones she used. Boy, talk about security! The five dollar chips were red aerodies from an old place she used to own across the street called Moms. They had Moms on one side and \$5 on the reverse. Clara also had a box of matching \$25 chips which she kept under the bar. Every time I'd see her I'd talk her out of one but I only got a few. Clara said her son had a lot of old coins and trade tokens and I should talk to him. One problem though, he was never around. When Clara died he took over the operation of the Golden and had new chips made but it didn't last long and was closed.

Down the street was the International Hotel. There was a 21 game in there run by a Chinese man who had previously operated in Wells. Unfortunately the chips only had chinese characters on them. He said they had been used in a poker game in Sacramento at one time.

Heading east out of Austin, it was seventy miles to Eureka, with nothing in between. The biggest place in town was the Lincoln Hotel but the casino had closed about a year before I first got there in 1969. A lot of the equipment was still there but was piled up in a corner. Also, the owner, Blanche Olinger, had been murdered in one of the hotel rooms some years earlier.

Anyway, sometime in the early 70's, I believe, the place was taken over by a man named Francis Escobar and renamed the Alpine. He told me that he would drive around and pick up hitch-hikers in the desert and offer them jobs at the hotel. It was the only way he could get help he said. Anyway, he had some pretty creepy looking people working there. One day I noticed a wheel of assorted poker chips sitting on an old poker table. They were mostly plain non-descript ones but one of the tubes had some purple BC Wills stamped LH and \$1.00 on the reverse. I knew they had

to have been used there when the casino was open. Anyway, when no one was looking I borrowed about ten of them. I'm sure no one missed them and I was glad to get them.

Next door to the Lincoln Hotel was Louie Gibellini's place. I got to know him over the years as a state champion single-jack driller. He competed in Tonopah at Jim Butler Days before they moved the competition to Carson City during Nevada Day. Even then he was probably in his sixties. Whenever I got to Eureka I'd stop by the bar and talk to him. At one time he operated a 21 game but it closed around 1966 a couple years before I got to town. The table was still in the bar in the early 70's but Louie could never come up with any chips much to my disappointment.

Across the street was the Nevada Club, Gold Bar, and Owl Club. There were only slots at the Gold Bar but it was still a neat old place.

The Nevada Club had a lone 21 game that was installed in 1969. I remember I was there when they first opened it and was able to get the original chips that were marked with a small nc and \$1 and \$5. They were white and green respectively. I guess later they were replaced with some that had the name spelled out.

The Owl Club was owned by a grouchy old guy named Vic Bereincua. He had some slots and a 21 game that was hardly ever open. One day I asked him if he had any old chips since the place had been open since the 50's. He said he had a lot of them in the basement but couldn't get them right away. So I hung around for a while playing the slots and sipping beer. After a while he came up to me and handed me some \$5 and \$25 chips that were stamped with his initials, VB. Also there were a couple that just said Owl. He mumbled something and walked off. I was glad to get them.

There was a bar across from the Owl called Jim and Lorraine's that didn't have any gambling but Jim had a blue, \$5 chip, Diamond mold in the cash register that was stamped TC. He said he had taken it from a guy who said it came from the Tonopah Club. I gave him \$5 for it and never saw another one like it.





Leaving Eureka, the loneliest road stretched another 77 miles to Ely. Finding obsolete chips from there proved to be a difficult task although I did manage to find a couple from the Alpine and Town Club. Over the years I got several from Norm Foeringer who owned the Nevada Hotel which was the main place in town. One time, my friend, Louis Dotson, from Wendover, gave me some \$5 blue BC Wills from the Northern, a place his father ran from 1959 to 1964. I also got to know Frank Smith who ran the Commercial Club in Ruth, a small town out of Ely, but he could never come up with any chips with a name.

Kitty-corner from the Nevada Hotel was the shuttered Bank Club which was owned by the late Bud Simpson among others. There was an attached bar called The Lounge which was open though. I soon learned that there were several boxes of \$5 black, BC Wills chips in a drawer in the back bar. One time the owner gave me a few and every time I'd go in I'd con the bartender on duty out of a few more. It was always one of my favorite chips.

Pinky Simpson, Bud's widow, owned the Mustang Club across the street from the Bank Club. It was a small place and had a 21 and a crap table. Also, in the back was a pan game where there was always a bunch of old-timers playing. There were 10¢ and \$2.00 well worn chips in play but I was never able to buy any. The guy who ran the game was adamant about letting any out. Later they ordered new ones on a different mold but I still couldn't get any. The name of the place was changed to the Saddle Club in 1975 but was basically the same. It closed four years later and was turned into a restaurant.

There was a place a few miles north of town called the Fireside Inn. I remember a 21 and roulette game in operation which I thought was a strange com-

bination. Anyway, I was glad to get chips from a rapidly declining part of Nevada.

Back in downtown Ely was a bar called the Pit. The live gaming had ceased in 1968 about a year before I got to town. One day I asked the bartender if any of the chips were still around and he said they were all in the basement. He said if I waited until he got off at 5 o'clock he'd get me some. That was a couple hours off but I hung around anyway. He did get me a set which was five or six chips and I was glad to get them. Still, I had to drive back to Reno that night which was 317 miles. It made for a long day.

So anyway, highway 50 certainly was lonely but I had a great time driving it. It's been many years since the last time I experienced it but I still have vivid memories of the great times I had.





# CONFESSIONS FOR THE MILLENNIUM:

#### CHIP PRICES ARE TOO HIGH!!!

I confess that "chips are too high"!!! And, as we approach the millennium it looks like they will get even higher. Not that long ago, like in 1993, I had dreams of grandeur that a chip might fetch over \$500 if it was really hard to find. Now, we see chips sell for well over \$3000. The explosion of gaming, not just in the USA but world-wide has created a demand for casino memorabilia that seems to be the tip of the collecting ice-berg. My confession stems from years of trading chips with little regard to relative values and dealing with a handful of "weirdos" that decided they did not want to leave all the chips on the tables and brought a few home. I never dreamt that walking with those dirty quarter chips from the craps tables would someday bring retirement income that well surpasses most social security checks. I confess, chips are too high.... and let's all hope they continue to rise to assure the expansion of the collecting base.

At every chip show or meeting with chippers, someone will invariably criticize the cost of buying chips and whine that "its going to ruin the hobby", or "if chips get any higher, I am just going to sell out"! or "I want that chip, but I just won't pay such a ridiculous price (more later, buddy)"!! The same complaint is heard over and over, year after year. But then, the complainer goes home to his collection, digs out his precious chips, and with a "Midas" drool, wallows in his increasingly valued hoard. And you can bet that he did not pay what he recently found out how they were "ridiculously" prices. Why can't they realize that higher new prices will also raise the price on their chip collection and increase their net worth? I confess, I will never know why. Some people just want to complain.

### "DEALERS"..... ARE A LOUSY BUNCH OF BACK BITERS

Recently, a person in gaming, but a non-collector, observed to me that every chip collector/dealer (a matter of degree) that he meets will criticize and often demean his fellow collector/dealer for some infraction of ethics bordering on criminal activity. "Why is it that you guys continually rag on each other in private discussions and turn around and deal with each other like

nothing is wrong"?

I confess...... I do it too, and I do it too often. The combative climate of our "hobby" has not so much changes, as matured with the increasing values and investment qualities noted in the above confession. In the past, if my fellow collector overcharged me, or undercut my price on a chip; it was a minor everyday "deal". Now, it can cost me rebates of hundreds of dollars and/or the disaster of lost integrity. Will likes, deceptions, cheating, and even stealing increase to the point that can question the future of chip and token collecting? Nah... it's always been that way on a smaller scale. There are just more "dealers" and higher values that magnify an old tradition. And, don't try to deny that WE are ALL "dealers" even if you only trade one or two chips compared to those you see at chip shows with books and tables of stock. It's only a matter of degree.

In the marketplace of chip collecting, invariably someone will have the same chip at a lower or higher price than another. Someone will always have paid too much or too little for the same chip. Everyone overprices or undercuts. The market will never be perfect. We will reflect this situation with criticism at the first opportunity because we want to justify our own integrity and how criminally the other guy seems to be acting. And yet, the majority of these combatants remain good friends and genuinely warm relationships prevail because the undercurrent of understanding tends to offset "that's the last time I'm ever going to deal with the guy" syndrome. The ones that cannot mellow and go with the flow are no longer around or will eventually leave the hobby. The extreme liars and cheats that are incorrigible never last in any endeavor and thankfully that includes chip collecting. But for the majority of us that are guilty of criticism, backbiting, "rag-ing" and "charging too much" ... I am thankful that tolerance and time can heal all the damages we suffer, and hopefully repair the damage we incur with each other and remain civil "dealers".

I confess, I don't know how we do it... deal after deal, year after year. We must work at improving and maybe someday turn the trend around. Ha! It may take another millennium.

#### I HATE - (D), COMMEMORATIVE CHIPS!

Yes, I confess that I said this too many times and for too many years. Most of the time it was out of pure frustration and inability to be at the cashiers cage the day they were issued to get "my fair share"!!! Why should those guys that live in Reno or Las Vegas get

"my share"? Even if it was only a fair share of ..."one"? A year after the keystone "Sailboat" chip came out, I suffered increasing frustration and indecision with all those pretty chips that seldom stayed in the racks and later never even came close to the "pit", much less become a worn, memorable, gaming object. How can any "real" chipper specialize in collecting all those issues that carry no memories of play while "running a streak at craps" or "leaving Reno with my last quarter chip at 5:30 in the morning and just enough gas to limp home"? They seldom even got dirty if you just stood in line (once or twice) at the casino main cage and carefully kept it in "uncirculated" condition.

Well, now those chips and those collectors that I wrongly criticized can be defined as the future of chipping in the new millennium. A younger, richer and more vibrant crowd of chippers has changed the face of chip collecting to a degree that most of the old-timers should just stand in awe. I can't begin to count how many new issues have impressed gamblers and nongamblers that became collectors since 1990. I have no idea how many commemoratives, limited editions, and "whoppee" chips have been made that brought new chippers into collecting. Just ....LOTS! And a lot more will come in the future.

Most of the time, these newcomers just pick up one or two chips that depict their favorite baseball player or stage act. Eventually, they come around to specializing and some fall into the abyss of trying to collect ALL of the new issues.... and some try to even buy more than one. A few even try to buy a box or THE WHOLE ISSUE. I even believe one or two of these hoarding chippers even had to go back to the cage sometime later to sell them back in their need to buy food. Ha!..... what a great hobby.

I finally had to take a closer, less biased look to realize these new chips were here to stay and had contributed to the growth of not only the hobby, but the whole chip manufacturing industry. It took chipping to a new level and created a new interest in collecting that provides a broader base and stronger demand.

I am still an "obsolete" chipper in many ways and prefer chips reflective of my era. It is wonderful when I see the progression of the newcomers that started with commemoratives and progressed to obsoletes. Not all of them, but enough that I feel confident that they will eventually create a much greater demand for obsolete chips than we can ever supply. It's already happening. No matter how many new "finds" of obsolete chips occur, the increase in interest has created an

awesome escalation of previously middle-priced chips. Forget the big deals that pay horrendous prices in auctions and legendary sales on one or two (now ten or twenty) "rare" chips. It's the old common \$10-30 chips that are rapidly disappearing to the new collector that decided he wanted to complete his LE collection from a favored casino by buying a few from the past. We got em!! Hook, line and sinker!! And now, that supply and demand ration just became way out of balance.


Add a (d) to "hate" for me. I want to come into the new millennium with what is reality. Those commem's are here to stay. Wait til' those new issues for the turn of the century come out this year AND next. It's going to be fun... and costly; but just think of all those new collectors that will be exposed to chipping. 
Cross-section of solid woodframe to show

#### Silver Strikes

Last month my column was entitled, "Going, Going, Gone." Nevada made a liar out of me and I am delighted! There are so many new silver strikes coming out. True, many are because of the .999 being placed on the silver, but there are also new designs along with older casinos like the Las Vegas Club putting in the strikes.

My husband and I were out to Vegas in January taking advantage of the offers in regard to my birthday month. We were pleasantly surprised to find that Ralph and Donna Bjornson drove up from San Diego via Laughlin to spend a day with us. With Donna driving we were able to get out to the Opera House, Sam's Town and Boulder Station. We also visited some of the spots along the strip. We stopped in at Bally's and were fortunate to get the last two \$200 strikes that they had on hand.

We also met one of the new members, Jeff Barnard who was there from Ohio. It is always great to meet a fellow collector.

The next day Janice and Jerry O'Neal treated us to Vegas hospitality. They took us to Gaming Times for some needed supplies. Then we went out to Arizona Charlie's for dinner and then a foray to Fiesta. We ended up back at their house and had such an informative visit. You always learn more about the hobby in general just talking to these two and they are so willing to share their vast storage of knowledge.

When we returned home, we found several emails regarding my last column and also received a few phone calls on it. I was taken to task for calling the silver strikes – silver strikes. Almost without exception the fellow collectors we have talked to feel that regardless of what the name stood for originally, it is silver strikes now. Even the company that makes these refers to them as silver strikes even the ones that have no silver content.

One of the complaints I have received is something I have been guilty of in the past. So maybe if I see it in print – I will shape up! When we get an e-mail from a fellow collector, it should be acknowledged. If you are sent a list and there is nothing you need, at least click on Reply and type one sentence acknowledging at this time you have nothing to trade, etc.

I hope I have given people food for thought. Please let me know your ideas on the above whether you agree or not. Think what a dull world it would be if we all thought the same! Until next time - -





#### Silver Strikes of Nevada by Jack Haddock

New silver strikes are everywhere! Some are just adding the ".999" to the center silver but most are taking this opportunity to offer totally new designs.

The Reno-Tahoe Airport initiated the \$10 silver strike program back in 1994, offering two designs which are highly sought after today by collectors. In 1995, the airport offered a \$40 silver strike which commorated the Men's American Bowling Congress Tournament. The 540 mintage guaranteed it a place of high distinction in the hobby. Also, in 1995, the airport went to a six \$10 token series, all dated, with designs depicting several of the Reno areas events. The airport has had the same six designs for four years only changing the date each year. But in 1999, they have the same topics and dated 1999, but offer great new art work. The skier is outstanding, a especially created design with lots of action and detail. The "1940 Ford Coupe" and the "1934 Indian Chief" motorcycle are great additions. When flying in or out of the airport, see if you can put a set of 6 together. There are four machines on which to try your luck; one on each concourse and two in the main lobby.

The Las Vegas airport has their new tokens but they just moved the ".999" to the center and changed mints. The very rare "21 Spades" McCarran Airport (a short lived token from the first issues of the airport) brought over \$650.00 in a recent auction.

The Flamingo Hilton in Reno is adding a great deal of excitement to the hobby with their various issues. It started with the 1998 caricature resembling Madonna, which was short lived since she was no longer in the hotels "Famous Superstars" show. That token was immediately followed by the Year of the Tiger WITH-OUT a mint mark; then there was a mint mark and, a new discovery, reveals a tiger token which has the .000 on the rim instead of the silver center (old reverse die). Not done yet! In 1999, they issued the Year of the Rabbit with the old logo, apparently so the token would be available for the Chinese New Year, and weeks later there was a rabbit token with a "tenth anniversary" logo on the reverse. Some true collector tokens in this group!



The Sundowner finally released their three new strikes on "Presidents" weekend. They were mixed with the old ones which made is difficult to locate. Only one of the designs had been seen before, while the bronco rider and calf roper are something new.



Along with all the new strikes coming on line, the rare strikes are enthusiastically sought after. The older rarities like the Flamingo Hilton - Reno NO WORDS Flamingo bowling (250 made) brings about \$350.00. The new rarities include the Golden Gate in Las Vegas - Trolley and Bridge (600 of each made) bring \$65 each and the last two tokens from the Riverboat Casino in Reno (500 of each made) which closed before very many got into circulation are bringing \$75.00. Of course, they have to be found for sale in order to purchase them at any price.

Remember the \$2.00 and \$3.00 (solid brass), \$7.00, \$20.00 \$40.00 and \$200.00 silver strikes? Almost all gone! The interest in them is a true indicator of what lies ahead in this hobby with the \$10 silver strikes. Several of the \$7.00 strikes brought over \$100 in a recent auction.

New collectors are entering this hobby all the time. The big question is always; "how many collectors are there?" Several casinos have to restock their strike inventory every 30 days. That represents between 500 to a 1000 tokens. The tokens went home with someone whether called a collector or a person just wanting a souvenir. Several slot players who find one silver strike machine go looking for another at other casinos. Many people have a relatively small accumulation of strikes sitting in a drawer somewhere. The collectors who are willing to pay a premium for silver strikes are conservatively between 150 and 250. Those are the ones that have this hobby gaining notoriety and driving up the values. The collectors just entering the hobby are having to buy the older tokens that have been retired. This means the once \$14 strike now brings between \$18 and \$20.

In the next few months, over 50 new strikes will be issued around the state. Unique art work, improved detail and surfaces, errors, and special issue tokens are also adding to the interest in the hobby. Who knows, there may be some really rare silver strikes in the months ahead. Only a few casinos have chosen to remove the machines: Fitzgerald's, Reno; Harrah's, Las Vegas; and MGM, Las Vegas.

**EDITOR'S NOTE**: We share a very interesting, fun and exciting hobby. Along with our enthusiasm to collect silver strikes comes the responsibility not to harm it for the thousands of tourists and slot players who just

want a special souvenir, or the casino who offers the silver strike program. The avid collector must temper their enthusiasm and not become an aggravation to the casino by making requests beyond ordinary service. It is important that we not be taking liberties be phoning the Gaming Control Board or the game providers to discuss or inquire about questions or make comments about the business end of the hobby. If we get involved in anything but the collecting of the silver strikes, the games may become an annoyance. This means that if the few of us who are the most interested cause an aggravation to any of these entities, we could be the reason the whole hobby would disappear. Unfortunately, there are those who have done all of the above and the negative affect has been felt. Support our hobby, enjoy and take pride in your collection! Buy, sell and trade, but please don't interfere with the business operation that provides us with our hobby.




#### "OUT OF OHIO"

#### THE CLEVELAND SYNDICATE

According to records at the museum of the US Playing Card Co. in Cincinnati, these chips were ordered on November 1, 1926, by J.S. Bauer of Cincinnati.

Joseph Bauer owned and operated the Arrowhead Club for several years, and when the Cleveland Syndicate began to expand, the Arrowhead Club was an early objective. The club was located just outside of Cincinnati in the community of Branch Hill. Local law enforcement officials tolerated the existence of the club because it catered to the wealthy and employed the not so wealthy.

When county officials finally decided to inform Bauer that the club could not reopen for the 1934 season, Bauer had assured them that it wouldn't reopen. Bauer then died suddenly and mysteriously. After Bauer's death, Sam Nason, Bauer's assistant, reopened the club.

Though it wasn't known at the time who was behind Nason, Moe Dalitz admitted many years later at the Kefauver Committee hearings that it was the Cleveland Syndicate.

What you see within the filigree on the inlay is the back of Bauer's playing cards.

Other than these chips being part of Bauer's personal set and being used in private games, it is not certain if they may have been used at other clubs Bauer operated. What is certain, though, along with documentation, is that these chips were ordered by Bauer and delivered on November 19, 1926.


