

# Treasurer's Report

Well it's hard to believe how fast time flies as I have already been in the position of Treasurer a year now and completing my fifth report. The information contained in this report reflects costs and expenditures for the period of 04/01/08 thru 06/30/08. There was quite a bit of activity occurring during this quarter being that the Annual Convention fell into that timeframe. I wanted to thank everyone again for your support and especially all those Committee Chairman, Volunteers, and last but not least Mike Pasternack and Dawn Satter, for without them we could have never made the Convention the success that it was.

# Highlights of the Second Quarter of 2008 (04/01/08-06/30/08):

- Invoiced, packaged and shipped all remaining auction lots
- Balanced all books for accounting of the 2008 Convention.
- Worked with the BOD & Convention chairs to complete and implement the Riviera Incentive package.
- Filed Club Federal Income Tax forms for 2007 with the help of Mike Quinlivan
- Filed Nevada State Income Tax forms for 2008 Convention

### Club Accounts

The current balances as of 06/30/08 in the new CC&GTCC accounts are as follows:

Museum Fund Money Market	\$115,976.53
Life Membership Fund Money Market	\$ 74,013.03
General Fund Money Market	\$ 16,916.37
General Fund Business Checking	\$ 36,097.33
Total of all four accounts	\$243,003.26

The above totals do not reflect checks written in the amount of \$20,285.71 for payments that have not yet cleared and deposits in the amount of \$9,038.54 that were made after the 06/30/08 date. The numbers also do not reflect the large payment to the Riviera for the Convention costs that is due by the end of the month.

### 6<sup>th</sup> Annual Bruce Landau Memorial Auction

This years Auction went off better than anyone had expected and finished in record time. I wanted to offer a special thanks again to our Auction Chairman, David Spragg who made this years auction and tribute to Bruce a continuing success. I also wanted to thank those who have made donations of lots to the club and in particular.

David Sarles, who by his most generous donations, helped this auction raise more money for the club than we have in recent years. Below are the final numbers for the auction not including catalog sales and misc. auction related postage and supplies.

Total Revenue from Auction Lot Sales (Includes fees) - \$32,538.50

Total Paid to Buyers (Includes fees) - \$24,331.50 Total benefit to the club - \$8,207.00

### The Museum Fund

The total amount currently in the Museum fund as stated above is now \$115,976.53. This number does not take into account several transactions which happened after the 06/30 Cut-off. A large part of the money raised for the Museum Fund accounts this past quarter was raised at the convention from the sale of the painting, prints and chips that were donated by the artist Carlos Cartagena. We all need to offer a huge thanks to Carlos, as well as Tracy Crump, David Spragg, Gene Trimble, and George Maloof for making these donations possible.

Another large fundraiser once again for the Museum fund was the Grab Bag sales and a special thank you goes out to Debby Meister and Steve Palumbo for their work on this project.



Thanks to everyone again who took part in this promotion and I look forward to seeing everyone next year !!!!!!!







## 2007 OTY Awards The Palms Scores a Hat Trick!







#### **Museum Mission**

The mission of the Museum of Gaming History is to preserve collections, artifacts and archives for the purpose of educating the public through exhibitions, programs and information.

#### The Role of Programming

Museum programming is how the public component of a mission is carried out. As the world's first global gaming museum, the Museum of Gaming History will combine multiple subject areas and interactive learning to make information and experiences accessible to a broad audience. The Museum will build upon established success of The Casino Chip & Gaming Token Collectors Club, Inc. a not-for-profit educational organization, in presenting informative and entertaining programming about gaming history.

#### Audience

The Museum will have a diverse audience and will provide educational, engaging and enjoyable experiences for various age, interest and knowledge levels. Visitors will include:

- Members of The Casino Chip & Gaming Token Collectors Club, Inc.
- Visitors and locals with interest in gaming history
- · Casino executives and other industry employees
- Tourists interested in unique Las Vegas activities
- Researchers and scholars of gaming history
  Students studying gaming and its place in society over time
- · Collectors of gaming memorabilia
- · Public with a general interest in Las Vegas

#### The Visitor Experience

Visitors to the Museum will discover a vibrant, inviting place designed to provide a variety of experiences. Spaces will be flexible to accommodate exhibitions and events of

various sizes and types. The experience will be multisensory to reflect the experience of gaming. Patrons will see artifacts, view moving images, hear audio tracks and have opportunities for hands-on interactions. The Museum will be fully handicapped accessible and provide services that today's museum goers expect such as a café and retail. The Museum will make its public spaces available for rental so that groups can have a unique and fun venue for special events such as corporate gatherings, parties and weddings.

Visitors making use of virtual opportunities will have access to collection information, on-line exhibitions and retail that complement time spent on-site. The website will be customizable so that people can create their own sets of data and interact with other users. These elements will all combine to create a community that will make visitors active participants in the Museum.

#### Content: Exploring a Diverse Past

Gaming has held a place in traditional and popular culture for centuries worldwide. The Museum will use a comparative cross cultural approach to create programs that present gaming on a global scale. This will create an environment in which international discussion can flourish. Rather than a purely chronological or regional perspective, the Museum will work to explore how gaming has been similar and different through side by side comparisons. While Las Vegas will be a primary reference, a visitor might see an exhibition about dice games from ancient Rome, Pakistan and the United States simultaneously and be challenged to think about what if any changes happened over time and why.

#### **Using the Social Sciences**

When motivations, style and technology change, gaming is adapted to serve the needs and desires of people. Artists represent it, writers discuss it, and destinations are built around it. The Museum will use methods of social science inquiry from psychology, sociology and anthropology to ask basic questions such as:

- Who engages in gaming and Why?
- What are the commonalities and differences between games?
- · Where do we find examples of gaming around the world?
- · When did gaming as we know it begin?
- Why do people invest time and money in gaming?
- · How are rules decided in gaming?
- How have people cheated in gaming?
- How has gaming been monitored and regulated through time?
- What do we know about illegal gaming?
- · How is gaming related to other aspects of culture?

#### **Focused Subject Areas for Teaching**

The Museum will use gaming as a basis for bringing together information from multiple fields of study. Professional staff and visiting scholars will create opportunities for exploration of questions in such varied subject areas as:

Art

Where and how has gaming been represented in art? *Architecture* 

How have spaces been designed to accommodate gaming over time?

Collecting

Who collects artifacts and information related to gaming and why?

Creative Writing

How is gaming represented by authors?

Design

How does design influence gaming and vice versa? *History* 

How do historians reference gaming in their work? Who are the major figures in gaming history?

Math

What are the mathematical properties of various games? *Science* 

What aspects of scientific knowledge are parts of game design?

Statistics

How do statistical properties factor into games?

In addition to exploring such subjects historically, The Museum will be a resource for current educators to use in inspiring today's students. Lesson plans will be created with teacher input and will meet curriculum standards for different topic areas and grade levels. Students will be encouraged to create new interpretations of gaming that add to the world's knowledge.

#### **Tours**

Guided tours will be a major component of Museum programming. Trained docents will lead groups through the exhibitions and discussions to encourage learning in an entertaining, accessible style. The Museum will partner with schools, tour companies, convention planners, event planners and interest groups to market multiple tour options. Self-guided tours will also be available and will include printed and audiovisual materials to enhance the experience.

#### **Public Dialog**

Gaming can be simultaneously celebrated or criticized, leisurely or addictive, legal or illegal. The Museum will provide a forum for multiple perspectives in order to help us to think critically about our past, present and future. Dialog and sharing of multiple perspectives in a respectful

atmosphere will be encouraged. Opportunities on site will include public educational sessions, speaker series, and symposia. The Museum will also work with the media and others that want to reference the collections and gaming history from multiple angles.

#### Research

The Museum will provide ample opportunities for research about its collections and other resources. A library and archive will house items such as books, journals, articles, correspondence and photographs for on-site work by professional staff, scholars and members of the public. A digital archive will preserve the information in a format that ensures its longevity and allows distance learning via the web.

#### **Publications**

The Museum will work to develop a publications program to produce original research in gaming history. This will include books in print and electronic form, reference guides and documentaries in partnership with other entities. In addition, images owned by the Museum will be available for use in other publications. Revenue from the sale and distribution of such works will support ongoing programming at The Museum.

#### Retail

The Museum will include a retail program in order to extend the educational mission and fund ongoing operations. Visitors will be able to purchase books, games, logo items and other products relating directly to the collection and programs at the Museum. Original product development for all ages will be a priority. Sales will occur on site and online.

The Museum Store will strictly adhere to the ethics and guidelines set forth by The Museum Store Association. No items from the Museum's collection will be sold in the Store at any time. Replicas of collection items will be sold only when copyright permissions are in place. Companion literature will be included with the product that makes it clear it is a replica. Reproductions will be clearly identified as such.

#### **Donor and Membership Programs**

The Museum will work to expand the existing membership base of The Casino Chip & Gaming Token Collectors Club to create ongoing support. Individuals and corporations who support the mission will be offered various levels of membership in exchange for benefits such as exclusive programs, behind the scene tours and discounted admission and purchases.

#### **Fundraising**

Ongoing fundraising will be built into the programmatic work of The Museum. Professional staff will work to combine donations, earned income, corporate sponsorship and grants for a diversified stream of support. An endowment will be established and continually built to ensure long-term sustainability for the operation.

#### **Institutional Partnerships**

The Museum will form and maintain ongoing mutually beneficial relationships with other institutions in order to maximize use of resources and expand the programmatic reach. 

### The Ghost Casino



In 1904 Shorty Harris and E.L. Cross, a couple of prospectors, found a greenish colored quartz rock with streaks of gold. At the time the area was sparsely populated, in fact the closed resident to their find, an elderly man and his family by the name of Beatty, lived five miles away in a town that would be named after him, Beatty Nevada

What seemed like overnight, thousands of people from hundreds of miles away started to arrive in the Rhyolite area where the two found their first gold. Out of the more than 2000 mining claims in a 30 mile area, the most promising was the Montgomery Shoshone mine .Rhyolite is named after the silica-rich volcanic rock in the area. Several mining camps sprung up overnight. Beside Rhyolite, there was Orion, Bonanza, Gold Center, Bullfrog, Amargosa, and Jumpertown.



Owner of the mine, Bob Montgomery sold his interest in the mine to Charles Schwab for approximately 4 million dollars. That same year, Tom T. Kelly, an enterprising miner began building the famous "bottle house" built from 50,000 beer and liquor bottles.

In 1906 Ernest L. Cross sold his share of his Bullfrog mining claim for \$25,000 and purchased a ranch near San Diego, living there until he died in 1958. Shorty Harris remained a prospector the rest of his life.

By 1907 the thriving town of Rhyolite had 10000 residents. Today it is a ghost town. During the heydays, Rhyolite had full telephone service, a school for 250 students, 45 slaoons, a water company with piped water to homes, an ice plant, 3 public swimming pools, two railroad depots, hospital, police and fire service, 8 doctors, 2 undertakers, 2 dentists, 19 lodging houses, 18 grocery stores, hundreds of homes, opera house, slaughter-house, foundries, machine shops, and 400 electric street lights. The town also had an active social life including baseball and basketball games, dances, tennis, a symphony, Sunday school picnics, pool tournaments, and Saturday night variety shows at the local opera house.

Rhyolite also boasted the first Catholic and Presbyterian churches in the Death Valley area. Over 85 mining companies were active in the surrounding hills. A ore mill was constructed to handle 300 tons of ore a day and included a crusher, 3 giant rollers, a dozen cyanide tanks and a reduction furnace. The town was home to three railroads, the Tonopah & Tidewater Railroad stretching over 160 miles from Ludlow California to Gold Center Nevada (South of Beaty), the Las Vegas and Tonopah Railroad stretching 210 miles from Las Vegas to Tonopah, and in June, 1907 the Bullfrog & Goldfield Railroad began passenger service covering 67 miles from Goldfield Nevada to Rhyolite. At one time the rail-

road sidings could accommodate over 100 rail cars unloading freight and then reloading with outgoing ore. The town was also serviced by three stage lines. In 1905 the towns newspaper, the Rhyolite Herald, began publication, and the post office was established

A town jail was built with 4 steel cells. Many impressive building were erected including the John S. Cook three story bank building and large mercantile store. H.D. and L.D. Porter brought supplies from their store at Randsburg, across Death Valley, arriving in Rhyolite they built a 1-1/2 story stone building and became the district's leading merchant. The Las Vegas and Tonopah Railroad depot was built of cut stone from Las Vegas with reinforcing made from railroad rails instead of lighter rebar.

Times changed rapidly after the financial panic of 1907 and the San Francisco earthquake in 1906. Financial backing started to dwindle with investors pulling out of mining ventures and by 1910 the towns population dropped to 611 residents. On March 14, 1911, the Montgomery Shoshone mine closed, and two weeks later the final issue of the Rhyolite Herald was published. By 1915 the town had only about 20 residents and the next year the power and light company ceased operation.

Soon the desert started to reclaim the town and all that remained were some shells of once beautiful stately buildings, dirt paths where city streets once were filled with people, the massive railroad depot which would probably stand forever because of it's method of construction, and the bottle house. In 1925 Paramount Pictures restored and reroofed the bottle house to use in a movie setting.



In 1924, N.C. Westmoreland rescued the depot and turned it into a roadhouse, the Rhyolite Ghost Casino and a museum. He ran the operation for 23 years. N.C. also owned the "Old Arizona Bar" in Las Vegas. His sister, H.H. Heisler maintained it later as a museum and gift shop. Today it stands closed and fenced on private land.

Today you can visit Rhyolite, located 4 miles West of the town of Beatty on Highway 374 in Nye County, the East entrance to Death Valley. Still standing are partial walls of the bank and mercantile store, the town jail, the railroad depot, and a few other buildings including the now famous bottle house. Take the time to walk some of the street paths and imagine the many people who once walked the same paths over 100 years ago.


Don't think you are seeing things as you approach the town of Rhyolite. Yes you did see a miner and a penguin. These and six other equally strange sculptures are exhibits at the Goldwell Open Air Museum at the entrance to the town. The miner and the penguin were done by Belgian artist, Fred Bervoets and is called "A Tribute to Shorty Harris", the legendary character who achieved fame and notoriety for his mining exploits and rags-to-riches lifestyle in and around Death Valley, the Bullfrog Mountains and of course Rhyolite.

# A Nevada Landing DIG for Chips and Tokens of Pop's Oasis!

Coming on the heels of the Hernando, Mississippi / Playboy Atlantic City casino chip Dig (CCTN Volume 21, Number 2, page 29, "The Playboy Find") we now have the Pop's Oasis Chip and Token Dig at the Nevada Landing!

For some of us, this find began with a fairly innocuous post on Greg Susong's on-line, Internet Message Board, The Chip Board.com.

This highly popular on-line gathering place of hundreds of casino memorabilia collectors from around the World provides a wealth of information 24/7, 365-days a year on our hobby, but sometimes you need to read the details.

Appearing in one of the nearly 100 threads created daily, was a post on June 12, 2008, simply

entitled: "Nevada Landing...". By opening the message, the reader was presented with this content:

"Probably not new news to most, but it was to me...some chips were found in the foundation of the Nevada Landing (well, what is left of it)"

Posted by Club member Paul Danielson, when he said "what is left of it" he was referring to the fact that last year the Nevada Landing Hotel and Casino in Jean, Nevada was closed and in recent months the building was razed.

No fancy implosion, just a swarm of bulldozers in the Nevada heat. Having been purchased by MGM/Mirage (as part of the Mandalay Resorts (previously Circus Circus, Enterprises) acquisition) it was decided that the Nevada Landing, which was right across the highway (I-15) from the Gold Strike Casino and Hotel (also MGM/Mirage owned) would get the wrecking ball and the land would then be developed for a planned residential community.

Danielson's post also included a link to another website called, "Leaving Las Vegas". That website is maintained by a local Las Vegan (Joel) who bills himself as a bit of a historian of Las Vegas. In visiting Joel's site, he pays tribute to past casino/hotels, motels, attractions

and other such historic elements of Las Vegas.

The site included a photo essay (with a few descriptions) on the life of the Nevada Landing. Jean, NV was certainly beyond the limits of Las Vegas proper, but Joel, according to his website, had often visited the Nevada Landing in his travels between Las Vegas and Los Angeles, CA., so it touched a nerve in this history-buff to document some of the demise of the Nevada Landing before it was gone forever.

Maintained in a chronological manner, Joel's site chronicled the final year of the Nevada Landing starting in March, 2007. With numerous pictures depicting the inside and outside the property (while it was still open for business) there are at least a hundred before and after pictures on the site.

In subsequent visits he took numerous pictures during the preview portion of the auction, and later on (August, 2007) as the "bull-dozers are starting to gather." Finally, in March and April of 2008, Joel had a segment that showed the building being gone and all that remained was the tall marquee.

In a final follow-up on the website, in late June (2008) he and his wife paid a visit to the cleared site and saw that the perimeter security fences had been removed and the land was more desert-like than it had been since the casino was first built in 1989 by Peter A. Simon, II of Jean, NV. (More on Simon in a bit.)

As described on Joel's website, he and his wife walked around the property, reminiscing about their past visits there when the Nevada Landing was open for business.

They walked the ground where they envisioned the restaurants to have once been as well as the Main Cage. Looking around they came across chunks of broken-up concrete, some of which had remnants of chips and tokens protruding at all sorts of angles.

It was upon closer examination that they could see that the chips and tokens were from the long gone Pop's Oasis, a casino that was located nearby, in fact, just feet away from the Gold Strike Casino, which is just across the highway (1-15) right there in Jean, Nevada.

On his website, Joel remarked how it was an act of homage to the old and Good Luck to the new, to place chips and tokens into the foundation of a new casino.

However, we collectors recognize this act to be more of a function of chip and token destruction,

and are aware that back then, it was a simple way to affect the destruction of some Pop's Oasis chips and tokens.

Of course this was at a time that the Pop's Oasis had just been closed (1988) (and torn down) and the Nevada Landing was just beginning to be built (1989). And since both properties were owned by the same person, Peter A. Simon, II (still more on him in a bit) it certainly stands to reason that this Find was the remnant artifacts of a chip and token destruction from a date some 21 years ago!

In looking at the post made by Danielson, there were only four other people that; read it, followed the link, saw the snippet about the Pop's Oasis chips and tokens, and then posted back that Danielson's message was an "interesting" read. Because none of the four replies made mention that the chips found were from Pop's Oasis, it seems that Danielson's post went relatively un-remarked about for several days.

But that would all change as the chip collecting World was just about ready to visit Las Vegas for the CC&GTCC, Inc.'s 16<sup>th</sup> Annual Convention and 20<sup>th</sup> Annual Business Meeting at the Riviera Hotel and Casino.

As one of the readers of Danielson's post and by happenstance, it turned out that my annual trek to Las Vegas (from Tucson, AZ) for the Convention was starting the week before the big event and I and the Family needed to make a brief side trip to Los Angeles, CA.

As we headed South on the I-15, I mentioned to my wife (Pam) about the Pop's Oasis chip find at the demolished Nevada Landing and we wondered if what Joel wrote about was real.

Within an hour we knew; there really were Pop's Oasis chips and tokens in the brokenup foundation of the Nevada Landing!

For our little 40 minute detour we collected a few examples of chip and token encrusted concrete chunks and highly damaged chips and tarnished tokens.

Although we had found a few examples of intact chips, they were definitely the exception and certainly not the rule. And even if wholly intact, they were subject to severe nicks, scratches and warpage from the stresses of being released from their concrete hold by the extreme forces of earthmovers and bulldozers.

It was noted that there were far more tokens than chips, and it was rather interesting that the tokens, by and large, were in new condition.

Although most were black or green from some sort of tarnishing, it was from later reports from others "prospectors" that visited the site, that once the green and black was removed (soaking in white vinegar) the tokens were like-new with little to no-wear. In fact, the partly reeded edges were like the serrations of sharpened knife blades!

It was during this impromptu visit that Pam lifted out this Trophy specimen, as shown in the picture of my son (Casey) and I with the still standing Nevada Landing marquee in the background.

This is a great looking chunk of concrete (in a nice symmetrical

shape) with multiple \$5 chips affixed and protruding from the mass of concrete. As seen here, The Trophy boasts 19 visible \$5 chips, 11 of which are fully intact. Additionally, there are 12 spots (impressions) where chips were once in contact with the concrete, but fell out when this chunk was broken free from a larger mass of concrete by a bulldozer. I can only imagine the full beauty of this rock if all 31 chips were still in-place and unbroken!

Pam also found this smaller example of a lone \$25 chip in the clutches of a glob of concrete. She suggested offering it up on eBay, and as we left Jean for Los Angeles, I photographed the piece on the dash of the car and with the aid of a laptop computer and broadband internet access, I created an eBay offering that was to begin later that day and run for 3-days; ending well into the first day of the Convention.

I then posted to TheChipBoard about the eBay offering (which eventually ended without a bid) and also about the Find!

Suddenly, Paul Danielson's post was read by many more people. My post was viewed hundreds of times and when we returned to Las Vegas the next day, in order to be at the Palms Casino Resort for Greg Susong's annual Chip Board Get Together, the "Dig!" was quite a topic of discussion.

I brought along 'The Trophy,' for collectors to see it first-hand, and noted that there was at least one other chipper in attendance who had also been to the Dig site. He was freely passing out Pop's Oasis tokens that he had gathered earlier in the day, as souvenirs for some of the attending collectors.

Over the course of the week (Convention week) there were several visits to the site by various other collectors. These early-morning visits (to avoid the heat of the day) turned up more of chips, tokens and chunks of concrete, and from time-to-time (during the Convention) I would be shown some items or heard stories from other people about their adventure to Jean, NV.

And while the majority of items found were tokens, followed by broken chips from Pop's Oasis, it was a bit surprising to hear of other tokens also being found at the site. All-in-all, there were a few examples (as shown in the picture) of \$1 slot machine tokens from Caesars Palace, the Mint ('79), Slots-A-Fun, Golden Nugget, Hilton (Las Vegas), Whiskey Pete's ('79), the Aladdin and even a token from the Royal Caribbean cruise line!

Also found was a badly damaged, non-denominated, Pop's Oasis, diecar mold, clay composition chip by co-author Jim Steffner, as shown in the picture.

Aside from that lone damaged clay-composition chip, all other chips seemed to be the well recognized, \$1, \$5 and \$25, Bud Jones, Coin-in-Center, diecar mold (incused) chips, as shown.

Before this discovery, it was generally believed that the entire rack of Pop's Oasis, Bud Jones chips were in collector circles already, so finding some in the foundation of the Nevada Landing begs the question: If the entire rack was in the collector community, then why would any of them be buried in the foundation of the Nevada Landing?

In trying to look back in time, one possible explanation is that the relatively minor amount of chips at the Nevada Landing site could be the remainder of turned-in chips following a redemption period some time back in 1987 or 1988.

Of course this would probably mean that the rack was already moved from the vicinity of the redemption location (probably the Gold Strike) otherwise it stands to reason that any turned-in redemption chips would have just been mixed-in with the rack when it was then made available to the collecting community.

But then that makes it difficult to explain the Dig chips. At the time of this writing, it is not specifically known how and when the Pop's Oasis rack entered the collecting community in the face of Nevada Gaming Regulations requiring some sort of "approved" destruction method.

Perhaps the buried chips (and tokens) were part of the "approved" destruction method and the remainder of the rack was somehow unaddressed. Such instances are not unknown to have happen in the past. (Look at the Dunes Golf Course chips, and the Sands, Las Vegas \$1 pinwheel chips, just to cite a few examples.)

In the research conducted so far by myself and co-author Jim Steffner (with the assistance of others) it is not clear when Pop's Oasis ceased operation, except that the consensus is some time in 1988. Even more confusing is when Pop's Oasis first had gaming! By one account, Peter (Pop's) Simon, a uranium prospector, bought the Standard Station (which had a 7-stool lunch counter) from a Shorty Smith in the 1940's and by 1947, the casino floor rivaled that of the Fabulous Flamingo!

That's right, some 27 years before the opening date of 1972 as listed in "The Chip Rack." And some 15 years before the opening date of 1964, as noted in the Campiglia/Wells "Official U. S. Casino Chip Guide". Although, the "Official" guide does conjecture that gaming may have been present at Pop's Oasis before 1964 in the form of slot machines.

Indications are that Pop's Oasis was closed between the opening dates of the Gold Strike (1987) and the Nevada Landing (1989) and all three were then owned by Pop's only child, Peter A. Simon, II, who was 24 years-old when he took over operation of "Pop's" legacy. (More on Simon, II, in a bit.)

Pop's, who came to the United States in 1898\* from Syria, somehow ended up in Southern Nevada as a prospector. Indications are, he was a pretty sharp guy. He owned several mines (gold and otherwise) and numerous claims, in and around Jean and Goodsprings, Nevada.

There is one account that for the fact that Pop's owned a Geiger counter, he, and two others, are credited for paving the way for the United States to become the leader in rare earth technologies.

It seems that the other two men needed to borrow Pop's Geiger counter to verify the radio-activity of some rock samples found by and held by another person. Pop's required an agreement with the borrowers, that they split 3-ways, anything that came of the effort.

This was in 1949 and bastnasite (a rare earth mineral) was what they ended up validating. It was found at Mountain Pass, California, and they subsequently sold their interests to Molycorp (of Colorado) for an unknown amount.

But the discovery lead to the access of large amounts of rare earth materials (and ore) which permitted research and experimentation, that propelled US scientists to becoming the principal source of knowledge for these materials. While many of these materials are used in everyday household items, at the time many had military applications.

According to Molycorp's website, they plan on re-opening the Mountain Pass facility again this year.

Pop's seemed to have a hand in quite a few things Southwest of Las Vegas, and also in North Las Vegas, and even Downtown Las Vegas. One such dealing was the development and construction of the "Simon Building" at the corner of 3<sup>rd</sup> and Fremont in Downtown Las Vegas in the 1950's.

The building was home to the Simon Rainbow Quarries (the quarries are now owned by Las Vegas Rock), a Photo Store, the Melodie Lane Restaurant and the IRS (on the second floor).

The Melodie Lane Restaurant was owned by a friend of Pop's, a Tom Panos. In 1945 Panos had opened a café in North Las Vegas, interestingly enough called the Oasis Café. Later on, in 1950, Panos operated the Nellis Air Force Base coffee shop.

What is also interesting to note is that Pop's is tied to a much earlier business venture on the North side of Las Vegas, where he allowed the use of an airstrip he owned for a fledgling airline that was to provide service between Las Vegas and Reno.

This was in the 1930's and while the airline failed, the airstrip later became Nellis Air Field. Perhaps it was between then and 1950 that Pop's may have befriended Panos, and when Pop's told Panos of his plan to build the Simon Building, Panos asked that he save the ground-floor corner location for Panos to open a restaurant. Pop's did and the restaurant was called the Melodie Lane Restaurant.

From 1972 to 1975 the Simon Building was the location of the Red Garter [Gambling Hall and Saloon] at 234 E. Fremont Street, but it is unknown if Pop's had any involvement with the casino, or if his heir had ties to the building which has since been absorbed by the Fremont Casino.

Pop's passed away July 2, 1980. It appears that his son (an only child) Peter A. Simon, II had already taken over operations of the family businesses at 24 years of age, some years earlier.

Aside from inheriting the material aspects of his father's life, he also turned out to be a pretty sharp guy like his father before him and I suspect some elements of his mother (Peggy, who passed away at age 98 in February 2007). Under his management, the Pop's Oasis casino leveraged Simon II into the Gold Strike and Nevada Landing operations.

Later, when they were acquired by Circus Circus, Enterprises, Simon II became an Executive at the Mandalay Bay Hotel and Casino, which continued when Circus Circus, Ent. became Mandalay Resorts.

Later still, when Mandalay Resorts was bought-out by MGM/Mirage, Peter continue as an Executive with MGM/Mirage, but he has since left and is looking to develop a casino in West D'Iberville (Gulfport), MS.

Simon II received approval (in 2007) for the site and has stated that he plans a 52,500-square-foot casino with 1,500 slot machines and 50 table games.

In looking back to when Simon II took over the business, again at age 24, he was interviewed in a local Las Vegas TV show called the Troy Cory Show. For readers with access to the Internet, here is a link to that 6 minute video:

In that episode from May of 1973, Simon II was a guest discussing his recent purchase of the Bonnie and Clyde Death Car. For those who have traveled between Las Vegas and Los Angeles, you might recall that the Whiskey Pete's Casino (at the I-15 and the Stateline, now called Primm) once displayed the Bonnie and Clyde Death Car.

While in recent time, the Death Car has been moved to the Primm Valley Casino Resort (now Terrible's Casino, Primm), but according to the interview of Simon II, he had it on-display at the Pop's Oasis Casino in Jean shortly after he acquired it for \$175,000.00.

However, according to another account, the Death Car was put on display at the Jean Raceway (owned by the Simon Family, as

was the movie theater, the church and other places in and around Jean, NV. In fact, Simon II was the Justice of the Peace for Jean.

But getting back to the Bonnie and Clyde Death Car, according to an internet source, the car was hidden behind a roll-up movie screen and every half-hour a film about Bonnie and Clyde (purchased from the Texas Rangers) would be shown on the screen. At the end of the film, the house lights would come up, as would the screen, thereby giving the audience a good view of the Death Car!

Quite the showman to say the least.

For this article I have asked the prospectors to show me their finds, or other photographs from the site. They are interspersed throughout this article and I thank them for their cooperation.

But the story does not end there. My co-author in this article, Jim Steffner, with assistance from myself, has been trying to contact Simon II or representatives of the MGM/Mirage, to solicit permission to visit the site (which is now marked with no trespassing signage) and attempt to acquire arti-

facts of the Pop's Oasis casino for the Club's "Museum of Gaming History" as part of the Club's Preserving Gaming mission.

Jim has made several visits to the Gold Strike and made numerous phone calls, seeking out MGM/Mirage executive(s) to pitch his case. He has also submitted written requests to the mailing address for Simon II, seeking his assistance in the cause. To-date, Jim has managed to get a telephone

interview with an MGM/Mirage representative that has responsibility for the Nevada Landing site.

That representative has told Jim, that it needs to be discussed at a higher level and he will get back to Jim later.

Hopefully, there will be a Part II to this story!

Our thanks to the several other "prospectors" (very similar to the tradition once established by oldtimers like "Pop's") for sharing their adventures with us by way of words and pictures.

I should also point out that the vast majority of the information contained herein was gleaned from the Internet.


# Hey Buddy, Got a Match?



Hey buddy, got a match? Now there's an expression you don't hear much any more at least not in everyday conversation. However, if you're a philluminist, someone who collects matches, you probably hear it a lot.

Sadly, today collecting in general has taken a real hit. We live in a fast paced world where people spend more time on the computer than they do interacting with other. I'm a phillunminist, roughly translated that means "lover of light", and over the last thirty years I've been collecting matches. For twenty six of those years I've been a serious collector and a member of the Rathkamp Matchcover Society, the granddaddy of match collecting clubs.


Like a great many people I picked up matches as a souvenir of a place I had been and threw them in a large bas-





I've always been a collector all my life. Stamps, coins, records, first day covers are just some of the things I've had an interest in over the years. I think I trace this back to my love for history. Matches, to me, are a very big part of history! Fire, of course, dates back to the cavemen, but the match as we know it only came to be in the early 1800's. There were many different tries a per-

fecting a safe and useful match and many failures. Early matches were nothing more than a highly volatile mixture of chemical substances diped into by a small splinter of wood that had to be rubbed between two pieces of sandpaper to ignite. As one might expect you had to do this very quickly or the sandpaper and possibly your hand might go up in smoke. Early match mixtures contained white phosphorous which, in addition to being highly volatile was also poisonous. Many early match company workers became deathly ill and succumbed to what came to be known as the "white death". In 1910 phosphorous was essentially banned



Year's earlier in 1892 a Philadelphia lawyer name Joshua Pusey, invented what was the first matchbook. His patent was challenged by Diamond Match and after a few years he sold his design to them for \$5,000 as well as a position with the company. In the early 1900's a new idea was born, using the match for advertising. The members of the Mendelson Opera Company took plan white matchbooks and affixed pictures and wrote about their upcoming performance on the front of the cover and even printed information on each match stick. These matchbooks were distributed around town and the performances sold out. The rest as they say is history. Later, around 1910 a salesman for the Diamond Match Company sold Pabst Blue Ribbon an order for 6 million



matchbooks and from then on matches as an advertising median became a phenomenon. With this kind of production "Please Close Cover Before Striking" became the most printed phrase in the English language.

Over the years many match companies came and went and the production of matches became a thriving industry. Since those purchasing matches wanted to get people's attention any way they could they asked for and got many beautiful designs very pleasing to the eye and, in some cases, almost a work of art. In the early 1970's the government forced the last real change in matchbooks by making it a law that match companies had to move the striker from the front to the back. Sadly, the advent of the cheap disposable lighter and the many prohibitions on smoking have slowly made the match industry a dying breed. Only time will tell just how long the remaining few match companies in the U.S. can survive in these very trying times.

Matchcover collectors obviously have a big concern about the dwindling production of matches and what it's affect will be on our hobby. Fortunately, over the year matches were produced in the millions and so there are a great many still available through the hobby for the collector. Very early casino matchcovers are highly sought after much the same as early casino chips but those from the 1960's, 1970's and 1980's were so overproduced that they've become quite common and easy to obtain and thus many collectors look on them with disdain. The growth of casinos around the country in other places than Nevada as well as the enormous building trend in Las Vegas has caused a rebirth of interest in casino matches. Most of the major hotels & casinos in Las Vegas have multiple matches in their restaurants, bars and clubs. Last year while staying at the Bellagio I picked up 15 different matchbooks and matchboxes from that one location. The new Planet Hollywood Hotel & Casino has had almost a dozen matches since it opened last year. Now many of the hotels and casinos are banning smoking and one wonders if that will mean an end to their ordering matches. We collectors sure hope not.

# Hard Rock Hollywood

## Blackjack and other Table Games

The first legal games of Blackjack and other card games in Florida were played on Sunday, June 22 at the Seminole Hard Rock Hotel & Casino Hollywood. In addition to Blackjack, the Seminole Hard Rock unveiled Baccarat, Mini-Baccarat, Pai Gow Poker, Let it Ride and Three Card Poker. 71 new tables for Blackjack and other games were installed at the Seminole Hard Rock as part of a major redesign and upgrade of the casino floor.

Blackjack and the other new card games are expected to attract hundreds of thousands of new players to Florida's Seminole Casinos, thanks to a compact agreement signed by Florida Gov. Charlie Crist and Seminole Chairman Mitchell Cypress in November, 2007. The compact was approved by the U.S. Department of the Interior in January of this year, when it became law. At that time, the Tribe made an initial \$50 million payment to the State of Florida, part of the \$100 million due to State in the first year of the compact.


Since then, the Seminole Tribe has made ongoing monthly payments to the State of Florida, while introducing Las Vegas-style slot machines at the Seminole Hard Rock Hotels & Casinos in Hollywood and Tampa, as well as at the Seminole Casino Coconut Creek and the original Seminole Casino Hollywood, the birthplace of Indian Gaming. Las Vegas-style slots were unveiled June 12 at the Seminole Casino Immokalee, near Naples, and June 16 at the Seminole Casino Brighton, northwest of Lake Okeechobee.

"With the introduction of Blackjack and the other card games, Las Vegasstyle casinos will now be at the doorstep of the residents of Florida," said James Allen, Seminole Gaming CEO. "Floridians won't have to go to Las Vegas or Atlantic City to play their favorite casino games."

"This is a first for the State of Florida and will capture the attention of visitors looking for gaming," said Nikki Grossman, President of the Greater Fort Lauderdale Convention & Visitors Bureau."

The redesign of the casino at the Seminole Hard Rock in Hollywood includes the installation of seven new olive wood trellises, which will make the areas for Blackjack and other table games more intimate and elegant. The trellises radiate out from the Seminole Hard Rock's Casino Center Bar. Of the 71 new tables, 55 will be initially dedicated to Blackjack, six to Three Card Poker, three to Pai Gow Poker, three to Let it Ride, two to Baccarat and two to Mini-Baccarat.

Blackjack and other card games will be launched at the Seminole Hard Rock Hotel & Casino Tampa late in 2008. No dates have been announced for the launch of Blackjack at the other Seminole Casinos.







2009 Convention location/dates are not finalized. The BOD is looking at other venues.

Election of Officers will take place before the next convention.

#### Membership issues

Dealing with dues and benefits. We will be focusing heavily on recruitment/retention. One proposal is to publish all non-renewing members in the magazine and ask that friends contact them about renewing. Question about privacy issues in printing names. The DNP list would not be included in that listing.

Capturing of member email addresses – We can capture the address of those who sign up/renew online. Currently we have only about 20% of the membership email addresses. The membership application has a space for email addresses.

It is possible that the Membership Committee will produce a coupon book as a benefit of membership. The book would include areas besides Las Vegas.

#### Planning Committee

Chairman resigned. The BOD wants to keep the committee going. President Thompson briefly explained the Committee's responsibilities.

David Spragg offered to chair the committee. President Thompson said that the BOD would consider his offer.

#### **New Business**

Swearing in of Membership Officer.

Eric Rosenblum - Parliamentarian, administered the oath of office to Steve Bedo.

With there being no further business, the meeting was adjourned at 12:00 pm.

After the meeting, the BOD gave those in attendance a chance to make comments/suggestions. (names of those who spoke at the microphone are included)

\*Dennis Shoop proposed a Jr. Membership program be developed and treated as an Associate member. Proposed that a Jr Membership cost? of regular yearly membership, have a special card and special number.

Questions as to whether Jr Members could participate fully due to the nature of the subject.

Question as to why the Club would want to create a new Membership level. Would require a Constitutional Amendment to do so.

\*Question about why forms for the Auction submissions and HoF nominations were not available online instead of being inserted in the magazine. President Thompson stated that some forms (Auction submission/HoF nominations/OTY program) were available online but that we could not stop doing them as magazine inserts because of the number of members who are not online.

Election forms must be placed in the magazine or mailed separately.

\*Sheldon Smith suggested that some civility on the BB's whether the Club's or those belonging to other persons might help promote membership.

President Thompson stated that we can only control the Club bb but that the BoD concurred with his thinking.

\*Robert McCollum suggested that those under 18 not be allowed to participate in the Club's activities due to the adult nature of the materials collected.

Suggested that seminars be timed so that dealers could attend.

Southern California dealers want the show to run longer.

\*Dan Ferris suggested that the Club needs younger members.

\*James Campiglia asked why we don't have a presence at other types of shows and offered to write articles for placement in other magazines.

\*Archie Black stated that if every member brought in just one new member that we'd double in size.

President Thompson stated that the Club will provide materials to anyone who wants to promote the Club at other shows. All a member needs to do is contact the BOD. Michael Knapp was writing articles for Casino Player (until they decided not to use more) and that any member was welcome to do so.

\*Question about an age limitation on Life Members. Concern that if someone became a LM in their 20s (after the 3 year requirement) that their one time payment would not be enough to carry them through.

I had the opportunity to attend the Casino Collectibles Show held on April 26 and 27 at the Bay 101 Casino in San Jose, California. Living in Toledo, Ohio, I usually just attend either local shows when I can, or more typically the two larger shows in Las Vegas. I needed to fly out to the Fresno area and San Jose would only be a few hours drive north. No matter what the reason, they all just seemed very pleasant. A far cry from many of the other casinos I've been to that make you feel like they are doing you a favor by letting you even be there.

The casino is comprised of two main gaming areas; California games (Century Black Jack, Pai Gow, Super Pan 9 and "Double Hand") with the right side dedicated exclusively to poker.

Bay 101 is open 24 hours a day, 7 days a week. The casino boasts 72,000 square feet with 40 gaming tables. Plenty of large screen flat panel high-definition televisions were mounted playing various sporting events; but most with the 76er's vs. Pistons in the play-offs.




Buzz and Armin





# **Logo Usage Policy**

The Club has certain logos and symbols which it must protect in order to protect its reputation in the collectibles community. No member is allowed to use the Club name, logo or symbol other than is approved by the by-laws or as otherwise specifically approved in writing by the Board of Directors.

- · Only members in good standing may identify themselves as members of the Club
- Any member who identifies himself/herself as a member must affix or state their membership number so as not to confuse the public.
- "Identifies" includes advertising, announcements, business cards, internet websites, internet or live auctions, e-mails and any and all types of communication.
- Every member must make an effort not to confuse the public or lead the public to think that the member represents or speaks for the Club, other than those officers who actually do speak for the Club or those who have been authorized by the Board to speak for the Club.
- No event, show, auction or convention shall use the Club name, logo or symbol for any reason whatsoever unless it is an event, show, auction or convention run by the Club.
- The Board has approved a "Member's Logo" which contains the member's membership number. Only that log may be used by members in their advertising, promotions, business cards, auctions, etc.
- Any other use of the Club name, logo or symbol must be submitted to the Board of Directors for their approval prior to such use.
- The entities formerly known as "Chapters" are prohibited from using the Club name, logo or symbol as representative of their organization



Please contact the Secretary for a copy of the logo with your membership number on it.

### CC&GTCC Claims Form

Up until now, there has never been a uniform, standardized way of filing a Claim against another member for an alleged Code of Ethics violation. Claims have been filed over the years in formats ranging from hand written notes, typed 5-6 page letters to just an email saying "I want to file a claim against \_\_\_\_\_\_".

Most of the time the information provided to the Club is vague and/or incomplete. The Claims Director may spend more time gathering basic information that should have been provided in the first place, than on resolving the issue at hand.

This form provides all the basic information needed by the Club, in written form, first hand from the member filing the complaint.

The process will work as follows:

- 1. Fill out the form completely, sign and date it.
- 2. Forward it Vice-President Jay Sands.
- 3. V.P. Sands will make an initial determination on the Claim.
- 4. If further action or investigation is warranted, V.P. Sands will forward the form to the Claims Director to open a Claims Investigation.
- 5. The Claims Director will work to mutually resolve the matter between the parties or if that is not possible, make a recommendation to the Board of Directors for the appropriate action.
- 6. The Board will act on the recommendation and the final report of the Claims Director. The parties involved will be notified of the final decision of the Board by Vice President Thompson.

IF you find it necessary to file a Claim against a fellow Club member, please help us to resolve the matter as quickly as possible by using the Claims Form.

\*The form will be available on the Club website at www.ccgtcc.com for you to download and print out. We are working on a program that will allow you to fill out the form online and send it electronically to Vice President Sands. We will notify the membership once this format is available.

## **Reward Fund**

Several years ago, the Club had a standing offer to help deter theft of member's collections. Somewhere along the way it was either dropped, forgotten or just faded into obscurity. The Board has voted to reintroduce the reward offer. We would like to thank Jim Reilly for his research and assistance with this project. The terms of the offer are similar to those used by the ANA. Please contact any member of the BOD for further information.

The Club offers a reward for information leading to the arrest and conviction of any person or persons charged with the theft of any part of a club member's collection.

The Club will pay a reward as follows:

If the retail value of the stolen property is less than \$5,000, the reward is \$250 If \$5000 to \$20,000, the reward is \$500 If greater than \$20,000, the reward is \$1000.

The purpose of this reward offer is to increase the likelihood of apprehending and convicting those who steal from club members, as well as to increase the likelihood of recovering the stolen property. The reward offer, however, is not intended to reimburse any club member's loss. It is each member's responsibility to maintain insurance against losses of this kind.


