





#### KNAPP ON BOOKS

This is the 30th installment of "Knapp on Books."

As with all reviews, this column contains my opinions.



Many of you know Harvey Fuller, or know of him. An ex-Los Angeles policeman, after his retirement, Fuller spent his time collecting chips and tokens and amassing information about the casinos that issued them. Most of the data Fuller collected over a period of twenty years was unknown to collectors. He infamously wrote his notes on keno tickets as he obtained them, largely based on individual conversations with old-timers now long gone. He also researched official records, where available.

Fuller's notes, however, were essentially inaccessible until Howard Herz painstakingly organized and "translated" the handwritten notes. Finally, 32 years ago, Howdy published Harvey J. Fuller's Index of Nevada Gambling Establishments.

That book essentially resulted in the induction of Harvey Fuller into the CC&GTCC Hall of Fame, based on his immense contribution to the literature and knowledge of the chip and token collecting hobby.

**FULLER'S INDEX PLUS: A Compilation of State, County and City Gaming Records 1927-**2013 (2014) by Howard Herz, Editor

My original 1991 book, 110 pages in length, covered the first 50 years of licensed gambling in Nevada.

Now Herz (one of the three original inductees into the Hall of Fame) has updated and supplemented Fuller's original work, resulting in this book.

The original Fuller index is contained in Fuller's Index Plus – it appears as the first section of the book, and its original 110 pages have been compressed to 40 pages. Herz's additional research and information comprises

the second section, an alphabetical listing of Nevada casinos resembling The Gaming Table style, and consisting of 541 pages of information!

Much of the information Howdy has managed to obtain is not found in any other publication. In addition to Fuller's original research, for this book Herz consulted Gaming Control Board records, Nevada Tax Commission records, records from County Sheriffs' offices, newspapers, phone books, city directories, and still more personal interviews.

The listings, by casino name, show addresses, owners' names, open and close dates, types of games licensed, and, uniquely, succession information as well. As casinos changed hands or as parts of their ownership were sold to other parties, separate listings appear so that it's possible to trace the history of the casino. To save the reader from having to calculate these successions himself, Herz has added a numerical notation as well, clearly showing the first, second, and subsequent ownerships and name or address changes.

Fuller's Index Plus reflects an amazing amount of research by two meticulous individuals, and adds incalculably to the literature of the hobby. It belongs in any serious collector's library. Copies can be obtained for \$55, postpaid, from Herz at <a href="mailto:chipsandtokens@yahoo.com">com</a>.

## Treasurer's Report

John Zoesch - Treasurer

The information contained in this report reflects costs and expenditures for the period of 1/1/2014 thru 12/31/2014

#### Highlights of the Third Quarter of 2014 (10/1/2014 - 12/31/2014):

- This guarter we had a net loss of \$4,832.
- The fourth quarter is always very quiet since the convention bills have already been paid and next years income and bills have not started yet.
- The clubs net equity went from \$328,759 to \$323,926 in the last quarter.
- This year we had a net loss of \$13,367 which is mainly from MOGH expenses of \$10,206.

#### Club Accounts

The current balances as of 12/31/14 in the CC&GTCC accounts are as follows:

General Fund Business Checking	\$ 16,602
Museum Fund Money Market	\$ 90,744
Life Membership Fund Money Market	\$ 63,277
General Fund Money Market	\$110,126
Total cash in all four accounts	\$280,749

The above totals do not reflect checks written in the amount of \$9811 that have not yet cleared.

As a method of comparison, in the December 2013 report we had a net cash position of \$294,117.

#### The Museum Fund

The total amount currently in the Museum Fund is now \$90,744. All expenses for setting up the displays at the Mob Museum and at the El Cortez Casino came out of the Museum Fund account as will the costs of any future displays.

#### **Greg Susong Memorial Fund**

The remaining balance of \$2089 that was donated by members will fund future awards. This amount will be kept track of separately until depleted.

#### Membership

This past quarter we took in \$5295 in membership payments. A good percentage of the members are taking advantage of the multi-year discounts and this will skew the numbers from year to year since their due dates are from one to five years out before renewal is due.

## The Member's Corner Steve Passalacqua CLM-044

Welcome to another edition of Member's Corner! This edition we feature the renowned Steve Passalacqua! Steve was the 25th member to enter the CC & GTCC Hall of Fame. He is also a dealer with a booth at the CC & GTCC Annual Convention. His personality and passion are a true credit to our club. I invite you to join me in getting to know him better.

Jerry: How long have you been in the club?

Steve: I have been with the club since the beginning. I am charter member CH- #44. I even placed an ad in the very first club newsletter from January-February 1988. I was happy that Archie Black was dedicating his time and talents to organize people that found chip collecting interesting and challenging. To this day every time I see Archie and his wife Brenda I rejoice in the fact that they were the engineers that supplied the glue to build the family of modern-day chip collectors.

Steve: Before Archie organized the club in 1988 and before e-mail, most chip collectors thought that they were one of the few or maybe the only chip collector. Finding a new collector that shared your passion for collecting gambling chips was a difficult and time-consuming task. I made up some red T-shirts with "I BUY OLD POKER CHIPS" in 1983 and we wore them to antique shows and street fairs. We went by the name T.D.S. ANTIQUE GAMBLING CHIPS, for Tegan, Drew & Steve.

Before Archie Black, Bruce Landau and Michael Knapp formed the club adding one new collector to your mailing or phone list was a triumph. In the early days of collecting most collectors sent their prized chips through the mail in a box. Many times the box was reused and sent with a label pasted over the old address. Twice I remember doing my best imitation of Sherlock Holmes and gently peeling off the old mailing label to see where the box had been before. I would then write to the old address explaining that I was a chip collector and wanted to know if they collected chips also. Both people replied with a yes and two more people were added to my prized list of chip collectors. From the very beginning I have been an enthusiastic supporter of our club and organized chip collecting.

Jerry: What are your particular interests in casino memorabilia?

Steve: My first memories of any type of gambling artifact was in 1961 (I was 11 years old) when my grandmother's 1880s antique ivory chips were passed down to my parents. As an 11-year-old I used them as building blocks to build small forts and houses. By the time I was in high school the ivory chips were used in our weekly Wednesday night poker games. If the Wednesday night game was not at my parent's house I would take the chips to the location of the game, no one wanted to play if we did not use grandma's set, everyone loved playing with these antique gambling chips. I've always enjoyed antiques and gambling so when I saw other chips at antique shows or flea markets they caught my attention. In the early days antique chips were around \$1 to \$5 each so they were easy to collect. In my first 10 years or so I did not collect casino chips, I thought to myself who would want to collect a chip that is only 20 or 30 years old? As an old chip collector I focused on Crest & Seals, DieCut monograms and engraved clay chips. As chip collecting gained momentum I gladly added casino chips to my want list with Lake Tahoe a high priority.

Jerry: What advice would you give any new members just joining our club?

Steve: It is a great time to collect gambling chips. There is no better place to find gambling chips or get a chip education than our annual club convention in Las Vegas. You'll find hundreds of people sharing your interest in gambling artifacts and will have the opportunity to add one or thousands of gambling artifacts to your collection. Collecting is a passion that can be enjoyed at any level from the beginner to the advanced specialized collector. In the beginning of organized chip collecting most chip collectors I knew had a goal to get one of every chip made. It took a while but we all learned that getting one of each chip was unrealistic. It is a good idea to form some parameters for your collection. I still collect everything chip related if it is at a price I consider reasonable. Collect what you like and create your boundaries within that group. You could focus on five dollar chips, one dollar chips, Las Vegas, California card rooms, illegal clubs, Crest & Seals or any other group that holds your interest. Education is the best form of protection from paying too much or buying something that is not what you thought it was. Most new collectors make these mistakes, I certainly have. As a member of our club you'll have access to reliable collectors and dealers, plus club members offer valuable advice and are eager to share their years of experience. Remember you cannot take a chip to a grocery store and get a bag of groceries or to a gas station and get a gallon gas. I collect gambling chips for fun, profit is not my first concern, but buying something and selling it for more than you paid is also fun

**Jerry:** Tell me a little bit about your personal life (wife, kids, family?)

Steve: My wife, Cathy and I were married in 1973, we have two sons and four grandchildren. Drew, our oldest son has devoted his life to education. After serving as a teacher, dean, vice principal and principal he is working towards his goal of being a school superintendent. Drew and his wife Kristy have three of our fabulous grandchildren: Scout, Augusta and Enzo. Tegan, our youngest son has devoted his life to the wine industry. Tegan has worked worldwide doing a wine crush in New Zealand, Northern Rhône, and South Africa. He is currently the winemaker for Turley Wine Cellars in St. Helena California. Tegan and his wife Olivia have our fourth fabulous grandchild William. Tegan and Olivia have launched their own wine label Sandlands and currently produce Chenin Blanc, Syrah, Carignane and a Grenache. On December 4th 2015 Tegan was named Winemaker of the Year by the San Francisco Chronicle.

Jerry: Where do you live and how long have you been there?

Steve: I grew up in the beautiful Napa Valley. Cathy and I owned our first house a small Gothic Revival in downtown Napa when she was 20 and I was 22. Jerry: Tell us about your career?

Steve: I drove a cement truck for 33 years, and I am proud retired Teamster. I started in the ready mix truck

business when I was 22. I had many trivial jobs before starting my driving career. My first real job was at 16 years old tearing down old buildings with a sledgehammer and crowbar in Napa for the recycling of building materials. At 22 I worked in the slot department of the Sahara Tahoe, had a fantastic time meeting Muhammad Ali and saw him fight Bob Foster. I still have the ticket stub and fight poster that Ali and Foster signed for me. When I left Lake Tahoe, Cathy married me and I started my driving career in ready mix.

Jerry: What would you like to see happen concerning the future of our club?

Steve: I would like members to sign up any relative as an associate member that might have an interest in collecting or sharing your passion. It could be your children, sisters, brothers, parents, grandparents, aunts, uncles, nieces and neph-



ews. Yes, you can sign up any relative for five dollars each. All these people young and old will receive a membership card and be introduced to the joy of collecting. I've signed up my wife, two sons, two daughter-in-laws, four grandchildren and a sister.

Jerry: Tell me something that nobody in the club knows about you?

Steve: My great grandfather Antone Passalacqua arrived in California in the year 1864. My grandfather Louis Passalacqua was a veteran of the Spanish American War in 1898. My father was in World War 2 and Korea. In 1927, my mother was abandoned at the San Francisco Ferry Building when she was a few days old, we never knew her parents.

**Jerry:** What other hobbies are you interested in?

Steve: I love anything that the grandchildren are interested in. I really enjoy home video editing and photo design. I enjoy music and listen to it when I can. I like to play poker. And my favorite sport is baseball. This year our sons and daughterin-laws bought Cathy and I tickets to game three of the 2014 World Series at AT&T Park in San Francisco, what a thrill! GO GIANTS!

**Jerry:** Give me your top things you want to say about the club?

- #1- I want to thank every volunteer that has worked for our club, the convention and our magazine over the many years of production. Everyone has done an excellent job.
- #2- The public and some members might not realize that our first rate organization is ran 100% by dedicated people who volunteer their time, talent and manpower to make everything happen. From the club officers to the people who volunteer one or two hours at the convention. These people work to furnish a habitat that the chip collecting community can share and enjoy.
- #3 Education is key to any collectible. The most popular area for chip collecting is the state of Nevada. The best way to stay informed on Nevada chips is to own a copy of The Chip Rack. ## **CC&GTCC Mentoring Program**

#### Introduction

The program is offered free of charge and available to everyone. The Mentoring Program is specifically designed for new casino chip collectors offering a wealth of information and experience of our seasoned casino chip and memorabilia collectors.

Seasoned collectors have gone through many a trial and tribulation, learning as they go and learning from their mistakes over the years. Knowledge increases little by little over time as we absorb what we can from our interactions with other collectors and individual experiences. If one is going to learn from mistakes, isn't it always best to learn from someone else's mistakes?

Collecting has many forks in its windy road, and is filled with many potential unwise choices, but our experienced collectors will help guide the beginner down the path.

They most likely have just a few chips, no price guides and no real idea of the best way to proceed with their new hobby. They often times have no idea how vast chip collecting is. That's where we come in!

#### The Program

The questions are designed to best identify your interests and to match you with a suitable mentor for your particular collecting interests.

Initial Stage: lasts for a period of 30 days. During this time, both parties will be encouraged to communicate back and forth through e-mails, and/or telephone. The mentee (new collector) will be open to ask any and all questions he may be interested in, and the mentor (experienced collector) will address the questions, giving advice and direction.

At the conclusion of the initial 30-day initial stage, the program chairman will contact both parties to see if both wish to continue. If both parties are pleased with how things are going, they may choose to continue for an additional 11 months. This short initial period is particularly good for beginners who just need a little help and direction while getting started.

Either the mentee or the mentor can conclude the relationship at anytime. This may need to be done because of unforeseen real life issues that may arise.

The program will continue for a maximum period of one year from the beginning of the initial active date, with a review after six months.

#### MoGH and ChipGuide Websites

The MoGH website received a makeover in mid-December. Besides having a nicer appearance, a new function was also added. The "Gaming Industry News" page used to show recent articles about casinos that were published by the Las Vegas Sun newspaper. Now you can select articles from not just the Las Vegas Sun, but from 13 other news sources, including: Google, N. Y. Times, Casino Journal, Casino Player, Global Gaming Business Magazine, Casino City Times, Tribal Government Gaming, International Casino News and CDC Gaming Reports.

To help support future MoGH exhibitions, a pop-up message has been added to the website explaining our financial needs and requesting a visit to our Donation page. The pop-up message is set to appear when first visiting the website and with every fourth webpage viewed thereafter.

The ChipGuide recently added its 140,000th item. You would think that we would be running out of new material by now, but the submissions just keep on coming in. ChipGuide administrators have now processed over 36,000 items submitted by collectors. What's hot and new? Harley-Davidson chips. These are souvenirs sold from Harley-Davidson retail stores; you can usually find a bowl of them on the counter by the cash register. Prices vary from \$1 to \$3 each, although they are \$5 at the store in NYC. We currently have more than 2,000 different Harley-Davidson chips from 400 locations on the ChipGuide.

Not much can be said right now, but the ChipGuide is working on something BIG. Hopefully, we will be able to make an announcement in the next few months. We'll keep you posted.




#### **CONVENTION BANQUET AND RAFFLE:**



went through a \$60 million renovation and redesign.

two renovated hotel towers with over 500 hotel rooms, several new restaurants and bars, and a 25,000 square foot casino.

In March 2014, the Park family acquired the property formerly known as The Horizon and announced a partnership with Warner Hospitality. A leader in gaming management, Warner Hospitality and its affiliated companies manage ten gaming and non-gaming properties throughout the United States, both in operation and under development. The Hard Rock Hotel & Casino project in Lake Tahoe marks the company's entry into the northern Nevada market.

### SUGGESTED TRADING CHIPS **POLICY FROM A MEMBER**

Richard "Reggie" Gummer R-7369

If you read the chip bulletin boards, you may have seen some of the comments that are being posted about the lack of chips being traded. I know from experience trading can be a little overwhelming to some people and especially to new chip collectors. A couple months ago Richard "Reggie" Gummer posted "rules" for trading with other collectors. Hopefully following Reggie's suggestions, and some of the activities that are currently being posted on the Chip Board, will stimulate trading among collectors.

Reggie's points are some good policies to carry into the arena of trading with other collectors. If we all think about to these guidelines we will hopefully be Happy Chippers. If you have any questions Reggie said to email him. With Reggie's permission, I am including the guidelines in this issue:


- A trading policy is usually never the same with any two chip collectors, having said that I will try to explain my trading policy.
- Let's go with the obvious first: commons for commons, current table chips for current table chips, new racks for new racks. Of course, there are always an exception or two to the above rule: For instance if there is a charge to get into the facility, or it is a member only club, you get my drift. I may want more than a common for a chip like a "Greenbriar" or a "Delaware Sport Lounge" (if I was to trade these chips at all.) A second exception would be; if you keep your trading inventory lean and mean...and you just ran out of a new common chip that is being offered for your older obsolete chip, and you have two or three of the older obsoletes. This constitutes a trade of equal value, because both parties are getting what they need/want.
- Denominations often throw new collectors a curve. Many cannot understand why they cannot trade a common \$5 chip for 5 - \$1 chips. There are several reasons that this is not something that some collector/dealers do not want to do. One is the ratio of \$1 chip collectors to collectors that collect higher denominations. Mostly, in order to acquire the five chips, (from the example above) it takes five times the effort, gas, and expense as it takes the one \$5 chip. And yes, the actual value is the same, but not really. Also, invariably the new or novice collector will stray into the higher valued or obsolete chips when picking the \$5 that he feels he deserves for the one \$5 chip. Some people are ok with this, when you find chippers like that, try not to take advantage of them. I lean on the side of not doing it, but possibly in part of a large trade, if the higher denomination is a chip I really want for my collection.
- Next there is a group of chips that are made available by dealer/investors that eventually flood the market, actually lowering the value of the chip below its face value; in some cases it is hard to give them away once you have been unlucky enough to acquire them. Examples of this are: Aces Casino, Jok-Erz Casino, Hard Rock Albuquerque, NM, Sonoma Joes, California Bell, etc. These can be mixed in with the commons in most cases. There are some in this group that are very slowly being meted out in order to maintain some value.
- Let's try and tackle the obsolete group...these have to be traded based on the Guides valuation. And/or the asking price. There are numerous guides, most people are aware of the

- TCR (The Chip Rack) which covers Nevada. There are also separate guides for AC, CA, WA,
- MT, and CO. There are also guides that such as the Official U.S. Casino Chip Price Guide, this guide covers NV, CO, SD (Deadwood), Riverboat States (IL, IN, IA, LA, MS & MO), and Atlantic City. There is one more guide that covers multiple states: A Guide to the Casino Chips of MI, MN, ND SD and WA, and many guides are available on the internet. I will try to help you hook up with the sellers of any of these guides should you be interested. One last thought on obsolete chips: It is always up to the two people that own the two chips that want to trade to be satisfied with the trade.
- If it is a lopsided trade where additional p/h is required, throw in a couple of extra chips (i.e. tokens always weigh more.)
- Always let the trading partner know when you receive your chips.
- Try not to send severely nicked, damaged, or extremely dirty chips.
- Some traders require a photo image preceding the actual trades, accommodate them unless you do not have scan capabilities.
- Try to be an equal partner in the trade, do not make one party of the trade do all the work.
- I prefer to trade with CC&GTCC members because of the honesty of this group is very high. However I have made trades with non-members.
- One type of trading I try to avoid is a lateral trading. This is when Trader A is getting a chip(s) that they need for their collection and Trader B receives a chip(s) in return that they already have. This trade becomes a wash for Trader B, they receive no additional value. I may do this if this collector/trader is a highly valued club member and customer, or a newbie to encourage their entering the hobby.

This is a work in progress, Reggie will be adding bullets as he thinks of them or suggestions from you are provided.



# What Can I Collect?



In each issue we shine the spotlight on a type of casino collectible and provide you with more detailed information about it.

In this issue we look at casino chips with unusual denominations.

Casinos have chips other than the "normal" denominations (25¢, 50¢, \$1, \$2.50, \$5, \$25, etc.). Some denominations (\$2, \$8, \$10, \$20) are more common than others (\$3, \$4, \$50).


And then there are the very unusual denominations include fractional monetary units, whole units, whole & fractional units and even fractions of fractionals.

### \$7 & \$11 chips

A \$7 Silver Strike is fairly common, but not chips. The Palms Casino in Las Vegas issued four different \$7 NASCAR advertisment chips with the No. 7 Jack Daniel's car.

The \$11 chip from Fitzgerald's in Reno, NV on the article cover page was used to pay an 11 to 1 bet in a game called Red Dog. This bet was paid if the same valued card (i.e., a Queen) was dealt from the deck three times in a row.





### **KENO**

Some Nevada chips were used to purchase Keno tickets. There are three known denominations: 60¢, 70¢ and \$3.60. Sometimes you can find the 60¢ and 70¢ chips for sale on eBay but not even the MOGH-Chip Guide website has a picture of the \$3.60 chip!



### 40¢ chips

This denomination is very unusual. CC&GTCC member Matt Elliot (R-8311) knows of five 40¢ chips all from his native Australia (Tazmania.)

#### Whole Unit + Fractional

Closed California card room Paul Cummins Roaring 20's used both \$1.25 and \$1.50 chips and the Top of the Vine used \$1.50 and \$3.50 chips. At least seven casinos have used \$7.50 chips to pay blackjack on a \$5 bet. Chips with 12.50 denominations have been used in Europe and Africa.

These unusual denominations and others just waiting for you to

### Others?

With a little bit of luck you can find casino chips with unusual denominations of \$200 and \$250 and if you want unusual denominations between \$1,000-\$10,000 from Nevada there are a few \$2,000 and \$3,000. Chips and plaques with denominations over \$100,000 also exist in small quantities.

There are home sets, lammers, personalized and fantasy chips that have unusual denominations. You can find Mother of Pearl chips/plaques on eBay with unusual denominations (mostly greater than \$1,000.)

### **Unusually Fun!**

Collecting unusual denominations can be challenging and making a new discovery can be very exciting. If you ever find a \$6 or \$9 chip, let me know!

### ONE OF NEVADA'S HISTORIC HOTEL CASINO

In the state responsible for modern day gambling, the landmarked Hotel Nevada in Ely, is a rare gem. I referred to staying there before last year's convention ~ regulation. in my article in issue 27-3, "Travels in the Minnie Van." The Hotel Nevada celebrated its 85th Anniversary last July 3rd. The hotel opened in 1929 during Prohibition and a mining boom in the area. The Hotel was ahead of its time- there was always gaming and alcohol available even before either was legal. The six story hotel was the tallest building in state well into the The hotel contains 67 rooms and suites to 1940's. stay in.

Just before I stayed there the ownership changed. It is now owned by John Gaughan and Paul Kellogg, and is managed by Gaughan Gaming. The previous



management had started to refurbish the hotel before the sale. In the guest rooms the furnishings have all been updated, new flat screen TVs installed, and Wi-Fi service is available throughout the building with a strong signal. The Hotel Nevada has installed the latest technology for


room access. Sorry to those of you who collect room keys- they give you a white credit card sized envelope marked with the room number, inside was a plain white electronic card about an eighth of an inch thick. You just wave it around the door handle, and voila the door is unlocked! The room I had was small but it much nicer than the casino hotel I had stayed in the night before. During the updating the hotel has kept its most famous trait: the water in the bathroom. The Hotel Nevada even makes fun of it, by having a warning and a cartoon about the consistency of the water temperature in the shower. Being that the plumbing and boiler are 85 years old there is a problem

with water temperature It goes from comfortable to ice cold to steaming hot to whatever without any notice so be prepared.



The Hotel Nevada has been "the place to stay" when in Ely or the surrounding areas. Over the years there have been many famous visitors who stayed there. The list includes Ingrid Bergman, Mickey Rooney, Gary Cooper, Lyndon Johnson, Wayne Newton, Vicky Carr, Jimmy Stewart, Hoot Gibson, and many other well known entertainers and politicians. The rooms that were occupied by this illustrious group have a plaque on the door that include information of who

stayed in it, why they where famous and if their stay was related to Ely. Inside these rooms, I have been told, includes memorabilia of the particular celebrity that stayed there. Several sources claim that the hotel is haunted, I was unable to find information to verify any specific visits. I know I was undisturbed in my room,





but I did heard a voice coming from the bar saying it was money that Doug Saito left there.

Along with being a historic building, the walls throughout the building are lined with historical photos, newspaper clippings and assorted antique curios placed in every nook and cranny. A visitor could spend the better part

of a day looking at the collection. The casino is small but has all the latest slot machines. The pit for table games opens at 11 am and stays open till the last



player leaves. It has three blackjack tables and one craps table. The poker table started at 6 pm with a whiteboard to use as a signup sheet. As I was playing at the BJ table an older woman was trying to get me to join the poker players so there would be a new player at the table. While I was at table they were training a young lady to be a BJ dealer. In the morning when




I came down to the restaurant for breakfast she was busthere sing tables. casino the believes in promoting from within.



As for meals, I had both dinner and breakfast in the Cafe, which is open 24 hours. The decor was family friendly with no pretenses and the food was good. ### For the Love of a Hobby

### Running a Casino and Gambling Memorabilia Show

With the opening of casinos in new jurisdictions, like Ohio, there is an opportunity to expand the hobby people in these regions, with similar interests to ours. Olmsted Township, Ohio resident and club member, Mark Britton has gambled that casino memorabilia collectors will come to his Gambling Memorabilia Show to bring home some chips. He is currently

organizing his 4th Ohio Annual Casino and Gambling Memorabilia Show at the Double Tree Hotel in Westlake, Ohio. These shows allow collectors to throw their money down on chips, dice, cards, silver strikes, matchbooks, ash trays and table felts from casinos from across the country. These shows are helpful to promote the hobby and the CC&TCC in areas new to gaming.

Some folks get hooked on gambling. Mark hooked the casino's themselves. He says, "I love walking around a casino, just having fun,

listening to the excitement ... just the whole atmosphere..." He's made seven trips to Las Vegas in the past several years and has been collecting for just about the same amount of time. He picked up his first chips while at the Casino Royale in Las Vegas with his wife, Tammi. "We were playing roulette, having a good time, and I wanted to keep a little souvenir. So I took one of my roulette chips and one of her roulette chips and put them in my pocket..." Unknown to Britton, at the time, he had chosen the one kind of chip that could get you into trouble. Criminals use the non-denominational chip to try scaming casinos, getting \$100 for a chip they paid only \$1.00 for. Later he found out tthat it was called "harvesting, very much frowned upon. If a casino catches you doing it, you will thrown out of the casino

for life. Luckily his souvenir did not get him into trouble and iinx his interest.

As we all know that there are plenty of chips to collect legally, of varying denominations, design, time periods and casinos. Some of us collect illegal chips from the casinos in jurisdictions that gaming was not legal. They are those places you knocked on the door twice and you told a big thug that Joe sent you and he would open the door leading to a hidden back room of a bar or restaurant where illegal gambling was going on. Other people collect wet chips, chips from just cruise lines, others focus on chips from Cuba, Nevada, or Las Vegas. Mark's wife Tammi collects chips with palm trees on them. She's goes with the tropical theme."

Mark collects items from the casinos he has visited personally. Along with Las Vegas, he's been to

Harrah's New Orleans. casinos in Gulfport Mississippi that were wiped out by hurricane Katrina and some in Indiana. Of course there's the Cleveland's Horseshoe Casino and Northfield's Hard Rock Rocksino. I'm close to a casino." Mark says, "my poor wife knows we're stopping in for a couple of chips, dice, a deck of cards and a player's card, and then

we'll be out." How many of us know about that?

As we all know, if you have caught the disease, chips are just one form of collectibles. Mark includes other casino collectibles, dice, ash trays, matchbooks, slot cards, room keys, silver strikes, menus, uniforms, security patches, slotmachines, slot machine glass, table felt, drink stirrers, napkins, bus sign advertisements, for his



shows. If it's not bolted down to the casino some of collectors will find a way to carry it out...collectors are crazy. Mark tells a story of a gentleman he knows...who was at the South Point Casino in Las Vegas, and he's into collecting a little bit of everything...he talked to the maintenance people and...he got a clean urinal screen that says South Point Casino.

Britton attended his first "chip" show in Battle Creek, Michigan six years ago after reading about it on the web-site The Chipboard. He attended the show, met some very nice people and formed a great friendship with Albert and Pam Scalzo the show organizers. Over the next several months they exchanged emails and spoke several times about creating his Ohio show.

Mark saw an opportunity. His Ohio show would be one of the few casino shows held outside of Las Vegas. Mark feels it is important to include all kinds of gaming memorabilia. With more casinos opening up in Ohio and across the country. he sees more things to collect and more people interested in collecting them. As many of us have found out, like Mark, that this hobby, is one our wives (husbands) are into as well. There are a lot of couples who collect together. It's not like a doll show where you see mostly woman or a military show where you see mostly men. He has met a lot of great couples through the hobby.

Mark's shows have had dealers coming from Indiana, Michigan, New Jersey, New York, Kentucky, and Ohio. Every year the attendance numbers through the door increased. The dealers' tables are sold out for the fourth consecutive year and he has other dealers on a waiting list."

Britton said, "The City of North Olmsted has welcomed me with open arms. Mayor Kennedy said "if you collect gambling or casino memorabilia

this is the place to be!" Mark plans to sponsor his show for many years to come and is already working on plans to celebrate his 5th annual Ohio show.

In no particular order, Mark has supplied a list of things to consider if you should decide to try to have a show in a different venue:

- I have been on both sides of the table over the last 47 years, I have bought and sold antique's since I was 5 years old. I did a lot of thinking and talking to Albert before I went on the Chip Board about the "Ohio Show". I wanted to put a show on to promote the hobby of chip and casino gambling memorabilia. So plan, plan, and find someone to talk to that has experience with organizing a show.
- Important considerations, you have to pick a venue that you can afford in your budget, you have to get dealers and you have to advertise
  - Venue: spend a lot of time on the phone and visit a lot of hotels, some are winners and some are not. I learned fast the vendors want to have the show in the same place that they are staying at. Roll out of bed and down to the show. Some hotels had great rooms but would not work due to loading and unloading of slot machines and other big items. Other are perfect but out of the budget. You must make sure that the location is in a safe place for all attending the show from the vendors to the general public. I looked at about 45 different place before I picked the one for the first show.
  - Vendors: are pretty easy to get, the first stop is the Chip Board. Then talk to other collectors and people in the area about selling slot machines and other related items. At the show you can sell anything that are related to casino's or gambling. I do not allow other merchandise.

- Advertising: this is a major challenge to do. The first show, I advertised in the following areas: news print, radio, flyers and the internet. I would say that flyers are a great way to promote the show. If there is a community bulletin board in any type of store event I put a show flyer up. I have them in antique store, grocery stores, book stores, restaurants, hardware stores and ANY other place I can put one up at. I do post the show on the Chip Board and other internet sites.
- The two things you have no control over is the following: The weather is a major one. The second one is the general public attending the show.
- I do this for the love of the hobby!!!! I do not do it for a profit. The first year I lost a lot of money and was told by my wife "you just had a very nice party for you casino friends." She told me that if the second show did not just brake even there would not be a third. I am just breaking even having the show, we need to grow this hobby. This is my number two hobby not my first. You must keep in mind that the whole show is funded by myself and only myself and a very understanding WIFE "Thank you Tammi".
- If we do not support the shows and clubs in the hobby, the hobby will not exist! I have collectors and dealers from across the USA to attend the show, but yet there are closer collectors that do not attend and I can't figure it out why



There are several communities that have Indian casinos along I-10 in California and Arizona. Due to the late start out of LA, we made our first stop in Palm Springs. There was two casinos in Palm Springs, the Spa Resort Casino is downtown and the Agua Caliente Casino right off I-10. Both casinos are owned by the Agua Caliente Band of Cahuilla Indians.

I was up early. Tina was not feeling well, so I headed out on my own around 8 am. The Spa Resort was my first stop. The Spa Resort hotel is located across the street from the casino. The casino is a nice size and nicely decorated. They have the normal assortment table games spread over 40 tables and a high roller's pit. The Paradise Rewards Club counter was open, so I signed up for a card. Alejandra who signed me in, was amazed at the length of my driver's license, NJ has 14 digits. She gave me a choice of two \$5 octagonal NCV chips or \$10 slot credit. Of course I took

the chips, used one Elvis' honeymoon house address and kept the other. I found the casino to be a very friendly casino to play in, and I can't wait to get back there.



Before going over to the Agua Caliente Casino, I took a drive up into the mountains to find Elvis and Pricilla's honeymoon house. Then I headed to downtown Palm Springs to look at local architecture, 1950s meets adobe. In the middle of town is a giant statue of Marilyn Monroe wearing the dress from "Seven Year Itch". 
On our way on I-10 Phoenix, still in


California, there were three casinos in Indigo, and Coachella right off the highway. The next grouping of casinos is in the Phoenix area. Scottsdale is a happening place in January, with a number of collectible auto auctions, including one at the Ft. McDowell Casino. After spending two days with friends, we headed off to El Paso to our next hotel. On the way



there, we made our only casino stop in Arizona at the Apache Gold Casino Resort for lunch and a break. The Apache Gold is on US-70 in San Carlos, Arizona. We used US-60 / 70 as a scenic short cut around Tucson it goes through Globe and San Carlos. Apache Gold is a small casino in the middle of nowhere. They had a

small pit, which which did not open till 4 pm during the week, surrounded by the slot machines. I signed up for their slot program at their cashier / club booth. While I was there I asked about obtaining some chips. A staff member was nice enough to open the chip cage, which only operates when the table

nos. Vicksburg is important in history for several reasons mainly, The Siege of Vicksburg, one of the final major battles in the War Between the States. There is the Vicksburg National Military Park, which includes



monuments. restored Union Gunboat, and a military cemetery along its 16 mile pathway. Another historic site, is the

Biedenharn Coca Cola Museum. This museum to put includes early bottling equipment, a early soda fountain, and Coca Cola memorabilia. Joseph Biedenharn is important to Coca Cola history because, he was the first bottler of Coke. Prior to this Coke was only sold as syrup to sell at soda fountains. Joseph Biedenharn was the first to convince Asa Candler, who was running Coca Cola, at the time, to sell him the bottling rights for the area around Vicksburg. At that time Chandler did not want up the capital that would be needed for being able to bottle Coke, believing that it was not a good investment. Another place to visit is The Army Corp of Engineer compound, which has the Lower Mississippi River Museum located on the boat with has exhibits on the history of the Mississippi River.


Vicksburg currently has four open casinos, which are a combination of land based and riverboat casinos. In the last few years, several casinos have closed in this area, as gaming has expanded throughout the country. Harrah's Vicksburg was one of them. All of the casinos are at the same exit as you cross the Mississippi River from the west. Two are just north of I-20 along the river and the other two are south of I-20. I only had time to stop at two of them. Diamond Jack's which is a riverboat casino with a land based hotel, and the Riverwalk Casino which is entirely land based. I started around 10 am. Neither casino was very busy. Both had friendly staffs in the small casinos. There was only two pits, and a nice variety of slots available to play in Diamond Jack's. The Riverwalk was a little smaller but newer than Diamond Jack's. The other casinos in town are the Lady Luck and Ameristar. Vicksburg was the last casino stop on the way home, which would take another two days. I did pass more casinos on I-95 in Maryland and Delaware on the way home, but that will be another story.
























Footnote to Travels in the Minnie Van

### GOLDEN BUBBLE GARDNERVILLE, NV










### RAY & RUTH'S STARDUST JACKPOT, NV









Although I was able to enter the Stardust after it had closed, around 1969. These chips came from another source. I remember rummaging around the place, there was a big hole in one of the walls. There was keno tickets, napkins, a bathmat and other items that bore the name Stardust. I was hoping to find a stray chip, but no such luck. I did obtain these chips a few years later from Jay Nady,

a gentleman who ran a chip and token service. He would go around to the casinos of Nevada buying their "foreign" chips for a discount and taking them back to the appropriate casino. Anyway, he got stuck with these and after some coaxing on my part, gave them to me. Ray and Ruth's last name was Fezler but I was never able to located them.

### SILVER CLUB [AS VEGAS, NV





The Silver Club was a Fremont Street joint that closed ten years before I got to town.\* I was fortunate though to work with one of the owners, Jimmy Young, at the Union Plaza in the early 1970's. We spent many hours talking about Vegas' old days and he told me many stories, mostly about dealing Faro to Nick The Greek at the Monte Carlo, another club that he owned. He also had his hand in

a few other clubs including The Boulder Club and the Zanzibar in North Las Vegas. Jimmy was a great source of information. I wish he was still around, I have a lot more questions.

\*Jimmy told me the Silver Club was connected to the Golden Camel Bar but separated by a partition, apparently this was an early practice. I remember the old A-1 in Wendover was the same way.

### PUSSYCAT A GO-GO [AS VEGAS, NV







The Pussycat A Go-Go was an after hours hang out located on the strip where the Wynn is now. If you went there before midnight there wasn't much business. However, after 12:00 am, the place was often packed, and the music was extremely loud. I remember two or three twenty-one tables and a few slots. I remember an old dealer

telling me that the dealers there often dealt seconds.

The \$5.00 pink chip with the green inserts I got around 1970. The other hot stamped \$5.00 chip came from an antique shop in town.

## It Happened on Fremont Street

### A Short History of Downtown, Las Vegas

This is an updated article published previously in CCN. Most of the photos provided are from Pam's vast collection of Las Vegas memorabilia. I have found her collection to be amazing in depth and variety and I hope you do also.

Before there was a Fremont Street...Helen Stewart: On April 6, 1873 Archibald Stewart and Helen J. Wiser were married in Stockton, California. Stewart was a successful businessman and rancher and shortly after the wedding the couple moved to an area near Pioche, NV. In 1879 Octavius D. Gass put up his isolated Las Vegas Ranch as collateral, and borrowed \$5000 in gold from Stewart. By 1881 Gass had defaulted on the loan and Stewart foreclosed.

In 1882 Stewart decided to move his family to the Las Vegas Ranch. He operated the ranch at a profit, selling beef, fruit and vegetables, and wine to mining camps in the area. He also used the ranch as a way station to serve travelers.

On July 13, 1884, Helen Stewart received a note from Conrad Kiel, the owner of a nearby ranch; "Mrs. Sturd send a team and take Mr. Sturd away he is dead." Helen rode to the Kiel ranch as quickly as she could. When she arrived Kiel and Hank Parrish lifted a blanket to show her the lifeless body of her husband, bloody from gunshots to the head and chest. Once she got the body home she had

her ranch hands use doors from the ranch house to construct a coffin, as there was no other source of lumber. She read the burial service over her husband's grave and had the body buried on the ranch.


Helen believed that Conrad Kiel, Hank Parrish and Schyler Henry (a former ranch hand for the Stewarts) had murdered her husband. Parrish had disappeared after the murder, but Kiel and Henry

went before a grand jury. Because there were no witnesses, there was no indictment. Helen believed that it was actually Parrish who had instigated the murder. In 1891 she made a note in her journal that Hank Parrish had been hanged in Ely, Nevada, who was finally brought to justice after a string of murder accusations.

Pregnant with her fifth child, Helen J. Stewart suddenly found herself with a ranch to run. She learned to manage the business ventures that her husband had run, and they continued to be successful. In addition, she had the foresight to realize that the Las Vegas Valley would become an important place as the growth of the West continued. With that thought, she bought acres of land around her ranch. By 1890 she was the largest landowner in Lincoln County.

In 1902, Helen Stewart sold the majority of her land to the San Pedro, Los Angeles, and Salt Lake Railroad, which was owned by copper magnate and Montana State Senator William Clark, Clark paid Mrs. Stewart \$55,000 for 1,800 acres, which included the ranch house and the water rights to the Las Vegas Springs, the ranch's water supply. also bought the Kiel Ranch, which was in the area now known as North Las Vegas. (Conrad Kiel died from natural causes in 1894; his sons Ed and William both died of gunshot wounds in 1900. Originally it was thought to be a murder/suicide, but the bodies were exhumed in 1975 and modern forensics proved that neither of the fatal shots could have been self-inflicted. Now ruled a double murder, it remains unsolved.) After selling the ranch, Mrs. Stewart had a new house built nearby and was a prominent member of the Las Vegas community until her death on March 6, 1926.

The auction: William Clark wanted Las Vegas to be a hub for his railroad, as well as other short-line railroads in the area. He intended to build a large train station, a repair shop and a staging area, as well as using it as a place to store train equipment. In 1900 only about 30 people lived in the Las Vegas Valley, including Helen Stewart, her ranch hands, and a few members of the Southern Paiute tribe. In

order for his plans to succeed, Clark needed to have people move to the Valley.

Clark's railroad drew a map for a town site on 110 acres of the land that he bought from Helen Stewart, and posted copies of the map in Salt Lake City and Los Angeles. The railroad offered special round-trip fares of \$16 from Los Angeles, and \$20 from Salt Lake City, and promised to refund the fare to anyone who bought one of the 1,200 lots that were offered for sale.

The land auction was held on May 15, 1905. It warmed up to 110-degrees, and more than 1,000 people crowded around the canvas-shaded wooden platform where the auction was held. The site was near the present-day location of the Plaza Hotel & Casino. At 10:00 a.m. auctioneer Ben E. Rhoades started the bidding, which continued until 3:00 p.m. By that time 176 lots had been sold for a total of \$79,566. Sales resumed the next day and by the end of the sale over 600 lots had been sold, yielding over \$265,000 for Clark.

By 1909 Clark had enlarged the rail yards and repair shop and was employing over 400 people. In that same year legislators voted to create a new county and named it after Clark. (Previously Las Vegas had been a part of Lincoln County.)

When his senate term ended in 1907, Clark left Montana for New York, where he built a lavish mansion in Manhattan. In

the early 1920's he sold his share of the railroad to the Union Pacific. William Clark died in 1925.

### 1 Fremont Street

Hotel Nevada: John F. Miller was born on August 1, 1864. He married Rosa Marchetti and they had seven children; Helen, Opal, Abe P., Jack, Frank, Dan, and Harry.



John arrived in Las Vegas on the first passenger train reaching Las Vegas after the railroad was completed in 1905. He attended the land auction and bought three lots on the southeast corner of Main and Fremont, across from the railroad station, for \$1750. Miller built a two-story, 35-room hotel that he opened in 1906 as the Hotel Nevada.

It was the first hotel in Las Vegas to be built from concrete. It was \$1 a night to stay in one of the luxurious 10'x10' rooms, which had electric lighting and steam radiators. In 1907 the first telephone in Las Vegas was installed in a cigar store that was in the lobby of the Hotel Nevada; the phone number was 1. For many years the Nevada Hotel was known for serving the best food in Las Vegas.

Sal Sagev: In 1931, the same year that gambling was legalized in Nevada, construction began on Boulder Dam. Two more floors were added to the Hotel Nevada and

the name was changed to "Sal Sagev" (Las Vegas, spelled backwards.) No one knows for sure if a gambling license was ever issued to the Sal Sagev Casino; in the early days they didn't always keep good records and many of the early Las Vegas records were stored at the White Horse Hotel in Carson City, which was destroyed by fire in 1960.

Several years ago club member Gene Trimble researched gambling at the Sal Sagev. He was able to confirm that the Sal Sagev had at least

roulette and blackjack in the early 1930's. In 1934 the casino was closed and the Albert Pick roulette wheel, along with five colors of roulette chips were wrapped in Los Angeles Examiner newspapers, and then wrapped in a tarp, and the bundle was stored at the Eye-witnesses told Sal Sagev. Gene that there was a poker table at the Sal Sagev from the late 1940's through the early 1950's.


Though John had seven children, it would appear that his son Abe, who graduated with honors from high school in the spring of 1930, was the one that was most involved in the casino business with him. A 1957 article about John Miller's death mentions that his son Abe

Golden Gate: The Golden Gate Club was one of eleven gaming license applications that were recommended for approval at the first meeting of the newly-formed Nevada Gaming Control Board on July 27, 1955. The approved license holders, as listed in the Reno Evening Gazette, were Alfred Durante, Leo Massaro, Italo Ghelfi, Robert Picardo, Fred Detore, Bernard F. Perata, A.A. Harris, Remi Gacherieu, and Abe Miller. The casino would be located on the ground floor of the Sal Sagev Hotel. It was noted that Abe was the owner of the hotel and would be paid \$2300 a month rent, plus 5% of the net gambling profits. Each of the other eight men would own 121/2% of the casino.

The casino opened on October 7, 1955. Symbols of San Francisco, such as the Golden Gate Bridge and trolley cars, were pictured on chips, dice, matchbooks and many other items used in the casino. Some of the early items,

including chips, coin cups, and ashtrays, used the name "Golden Gate Club." The casino was smaller than it is now, as there were other businesses located within the building.

Gene relates that sometime after the Golden Gate casino opened Abe Miller told one of the men that he had something for him "a souvenir of the early days of the Sal Sagev", and presented him with a wrapped bundle. The man took the bundle home, where he and his wife unwrapped it; it was the roulette wheel and chips that had been stored in the Sal Sagev since 1934. They had the legs cut down and turned it into a coffee table. In 1999 Gene saw the table and the 681 chips that were still on it. The chips Gene saw were: five brown, 200 white, 162 yellow, 162 blue and 157 green. He was told that the chips were not for sale.

A few years later the family that owns the table and chips sold 225 chips into the hobby, the rest were kept with the table. An additional nine brown chips had been found in the tarp that had wrapped the table. The roulette chips that were released into the hobby were: 14 brown, 42 white, 64 yellow, 28 blue, and 30 green. In addition the family had some red chips that weren't kept with the roulette table and chips because Abe's notes said they were used as \$5 chips. Forty seven of the red chips were released to the hobby with the roulette chips.

In 1959, The Golden Gate served their first shrimp cocktail (at a price of 25¢ each.) On September 26, 1991 they celebrated the sale of 25 million shrimp cocktails! The Golden Gate is still open and still selling shrimp cocktails. According to 2014 online information, they've sold over 40 million of them!

Ghelfi's stepson, Mark Brandenburg began working at the Golden Gate when he was 13 years old. In spite of the family connection he started at the bottom- mopping floors, bussing tables and parking cars. By 1990 he bought out the other partners. In 2008 he added partners Derek and Greg Stevens, brothers who would also purchase Fitzgerald's and transform it into The D. In 2012 the Golden Gate under-Du pont coccoccata the state of the state of

went a major renovation. including the addition of a new tower that contains 16 suites.

There have been other changes too: there's no longer a deli in the back of the Golden Gate, the shrimp cocktail has gone from 99¢, which was held for many years, to \$3.99 and it's sold in DuPar's Restaurant...

which replaced the Bay City Diner. The dealers are also dancers and there's a bar on the sidewalk.














#### 13 Fremont Street

13 Fremont Street was in the Sal Sagev Hotel Building, at the east end of the building, next to the alley that runs between 13 Fremont and 15 Fremont. Of course the Golden Gate Casino has now taken over the entire ground floor of the building.

personalized with the customer's initials, similar to other keychains that were given to customers back in the day. I was able to buy one of those keychains on eBay several years ago...the only one I've ever seen. Unfortunately, the keychain never arrived...just a plain white envelope that was tattered and torn. The seller refunded my money, but I'm still sad that the keychain was lost. The Golden Gate

Trail Café: Circa 1944-1945. Can't tell you much about the Trail Café except that it opened after the 1939 telephone book was issued and before the 1944 phone book was issued. It was listed in the 1944 and 1945 phone books, but closed before January 6, 1946 when an article in the Nevada State Journal shows John F. Miller getting a tavern license for the former site of the Trail Café. Did the Trail Café have any gambling? That's

a good question, and I don't have an answer to it. Since the Trail Café and Sam's Café share a matchbook, and Sam's Café had slot machines, it's possible that the Trail Café had slot machines as well.

Lanrep Bar: In the 1946 phone book.

Keyhole Bar, c. 1950-1955: I'm not aware of any gambling at the Keyhole Bar, but a bar...in Las Vegas...on Fremont Street...in the 1950's....should have had at least a slot machine or two, right? I don't know, but we have a cool book of matches to share, so I decided to include the Keyhole Bar here. I don't have the exact dates of operation, but it was listed in Las Vegas phone books from 1950-1955. As you can see on the matchbook, and in the photo, the door was a normal rectangular shape, but the doorway was in the shape of a keyhole...a unique little architectural detail!

Lucky 13 Club, 1955-1957: This small club, located in the Sal Sagev Hotel building, was licensed for slot machines and 21. As far as I know, no chips or ashtrays have shown up from this club, but there are some very cool feature matches. There are also Lucky 13 Club keychains,

Casino has expanded into the Lucky 13 Club's space. Next time you go into the Golden Gate, use the Fremont Street entrance that's next to the alley on the east end of the building and you'll be walking into the space that was occupied by the Lucky 13 Club.

#### 15 Fremont Street

The Stocker family: Oscar Stocker and Mayme Clifton were married in Reading, Pennsylvania on December 26, 1891. They had three sons; Lester was born on November 16, 1892, Clarence on April 10, 1894, and Harold on March 8, 1900. In 1904 the family left Reading. Oscar worked for the railroad, which necessitated several more moves before the family settled in Las Vegas in 1910.

Just months after arriving in Las Vegas, Mayme got word that one of her two sisters, both of whom lived in Butte, Montana, was very ill. Taking young Harold with her, Mayme left Las Vegas to be with her sister. Both of Mayme's sisters were married to saloon owners, so Harold spent some time observing some of the ins-and-outs of running a bar.

One summer, when Harold was 17, he went to work as a dealer in Tijuana. He started as a chip-stacker at the rou


lette wheel...the game that got the most play in those days, along with '21'. Harold met a movie producer who was in Tijuana for the summer; the man staked him \$500 to play blackjack. Harold worked out a system and by the end of the summer Harold's share of the winnings was \$6000.

Northern Club, 1920-1943: In 1920 Mayme Stocker opened the Northern Club, a rather classy bar and cardroom. She was the owner of record, instead of her husband, because the railroad frowned on employees being involved in drinking and gambling. While we usually think of 1931 as being the year that gambling was legalized in Nevada, there were five games that were legal in the 1920's; lowball, draw, and stud poker, '500', and bridge. There were few experienced dealers in Las Vegas in the 1920's, but of course Mayme had Harold.

Prohibition had very little effect on drinking in Las Vegas. Sam Gay, the local sheriff, felt that the prohibition laws were federal laws...and it was up to the feds to enforce it, not him. Police Chief Percy Nash didn't feel the same way. He knew that Harold Stocker kept a single pint of whiskey in the bar, and that was in his pocket. One day he threatened to jump over the bar and confiscate it. Harold told Nash that if he tried it, he'd put a slug from a .45 in Nash's belly. Nash, Stocker explained, was there to enforce city laws; federal laws were none of his business.

Stocker, Las Vegas was pretty small potatoes in those days...the feds had all they could handle in the bigger cities like Chicago.

According to a 1981 interview with Harold Stocker, his older brother Lester was a professional gambler. Lester tried unsuccessfully in 1925, 1927, and 1929 to get wide-open gambling legalized. In 1930 he called a meeting at a back table in the Northern Club. Harold reports that the meeting was attended by club owners, a high-ranking state official, a city councilman, a local businessman-booster, and two assemblymen. One club owner said "If I had some money





to spread around I could probably get it on." Most of the \$10,000 that was raised came from the Stockers and their business partners—primarily from Lester. Harold didn't know who the money went to, if anyone, but the bill was introduced by Phil Tobin, the legislator from Winnemucca. Phil Tobin always said that he never received any money for introducing the bill...he did it because he thought it would be good for the state.

When gambling was legalized on March 19, 1931, The Northern Club received the first Clark County gaming license, which allowed The Stockers, with their partner

To protect the Northern Club from any nosey federal agents, they served only mixed drinks. That meant that to prove the Northern was breaking the law, the drinks would have to be analyzed for alcohol. That was a lot of trouble and expense for a \$200 fine...so they just didn't bother. According to

Joe H. Morgan, to operate a gambling and slot machine business; they were allowed 2 slot machines.

The Northern Club closed in 1943. Lester Stocker died in 1934, Oscar Stocker died in 1941, Clarence Stocker in 1951, Mayme Stocker in 1972, and Harold Stocker in 1983. Turf Club & Bar, 1943-1944: The 1944 phone book shows Dave and Sam Stearns as the proprietors. Conflicting information says that Wilbur Clark opened the Turf Club in 1943, before changing the name to Monte Carlo Club in 1945. The Northern Hotel continued to operate on the second floor.

Club 15, c.1944?-c.1945?: Reference guides show that a "Club 15" was located at this address in the 1940's, but no specific years are listed. I've not found it in any of our books about Las Vegas, or in our phone books. I've listed it here, because there's a possible gap in the timeline. However, if the club was only open for a short period (a few weeks or a few months), it could fit in elsewhere.

Monte Carlo Club, 1945-c.1956: Wilbur Clark moved to Las Vegas, from Reno, in 1945 and opened the Monte Carlo Club as his first Las Vegas venture. With the profits he got from the sale of the Monte Carlo Club he began building the Desert Inn. Though ownership changed a couple of times, the Monte Carlo operated at this location until c.1956 (different sources have different closing dates; Monte Carlo is listed in the 1956 phone book, it's not in 1962, and we don't have the ones between.)

Pioneer Pawn Shop 1960-1965: Owned by Mr. Robert Powell (this information comes from the Pioneer Pawn website; the 1962 Las Vegas phone book does not confirm it).

Denny's Restaurant: circa 1967

Sam's Roast Beef: per the 1969 Las Vegas phone book

### **CC&GTCC Claims Form**

Up until now, there has never been a uniform, standardized way of filing a Claim against another member for an alleged Code of Ethics violation. Claims have been filed over the years in formats ranging from hand written notes, typed 5-6 page letters to just an email saying "I want to file a claim against \_\_\_\_\_.".

Most of the time the information provided to the Club is vague and/or incomplete. The Claims Director may spend more time gathering basic information that should have been provided in the first place, than on resolving the issue at hand.

This form provides all the basic information needed by the Club, in written form, first hand from the member filing the complaint.

The process will work as follows:

- 1. Fill out the form completely, sign and date it.
- 2. Forward it Vice-President Sheldon Smith.
- 3. V.P. Smith will make an initial determination on the Claim.
- 4. If further action or investigation is warranted, V.P. Smith will forward the form to the Claims Director to open a Claims Investigation.
- 5. The Claims Director will work to mutually resolve the matter between the parties or if that is not possible, make a recommendation to the Board of Directors for the appropriate action.
- 6. The Board will act on the recommendation and the final report of the Claims Director. The parties involved will be notified of the final decision of the Board by V.P. Smith.

IF you find it necessary to file a Claim against a fellow Club member, please help us to resolve the matter as quickly as possible by using the Claims Form.

\*The form will be available on the Club website at www.ccgtcc.com for you to download and print out. We are working on a program that will allow you to fill out the form online and send it electronically to V.P. Smith. We will notify the membership once this format is available.

### **Reward Fund**

Several years ago, the Club had a standing offer to help deter theft of member's collections. Somewhere along the way it was either dropped, forgotten or just faded into obscurity. The Board has voted to reintroduce the reward offer. We would like to thank Jim Reilly for his research and assistance with this project. The terms of the offer are similar to those used by the ANA. Please contact any member of the BOD for further information.

The Club offers a reward for information leading to the arrest and conviction of any person or persons charged with the theft of any part of a club member's collection.

The Club will pay a reward as follows:

If the retail value of the stolen property is less than \$5,000, the reward is \$260

If \$5000 to \$20,000, the reward is \$500

If greater than \$20,000, the reward is \$1000.

The purpose of this reward offer is to increase the likelihood of apprehending and convicting those who steal from club members, as well as to increase the likelihood of recovering the stolen property. The reward offer, however, is not intended to reimburse any club member's loss. It is each member's responsibility to maintain insurance against losses of this kind.




